

## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SEVENTY-ONE.

AN ACT to amend chapter eleven of the revised statutes.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- SECTION 1. Section ten of chapter eleven of the
- 2 revised statutes is amended, by adding thereto these
- 3 words, "and may invest such committee or supervisor
- 4 with all the rights, powers and obligations of school
- 5 agents, including the power of employing teachers, and
- 6 expending money raised for school purposes," so that
- 7 said section as amended shall read as follows:
- 8 Sect. 10. Every town shall choose by ballot at its
- 9 annual meeting, a superintending school committee of
- 10 three, unless already done, to hold office as provided
- 11 in section fifty-three, and shall fill vacancies arising
- 12 therein at each subsequent annual meeting, or shall,
- 13 in the same manner, choose a supervisor of schools,
- 14 who shall have the power and perform the duties,

- 15 which are now or may hereafter be required of the
- 16 committee aforesaid; and his election shall terminate
- 17 the office of any and all existing members of such
- 18 committee, and may invest such committee or super-
- 19 visor with all the rights, powers, and obligations of
- 20 school agents, including the power of employing teach-
- 21 ers, and expending money raised for school purposes.
  - SECT. 2. The fifth item of section twenty-four of
  - 2 said chapter is amended, by inserting the words
  - 3 "school agent," so that said item as amended shall
  - 4 read as follows:
  - 5 Fifth—To instruct the school agent, or the superin-
  - 6 tending school committee or supervisor, at what time
  - 7 the school shall commence, if they find it practicable.
  - SECT. 3. Section thirty-six of said chapter is
  - 2 amended so as to read as follows:
  - 3 Sect. 36. A school district, at a legal meeting, may
  - 4 determine what proportion of their school money shall
  - 5 be expended for the support of a summer school; and
  - 6 their agent, or the superintending school committee,
  - 7 or supervisor, if such committee, or supervisor shall be
  - 8 invested with the power, shall expend it accordingly
  - 9 practicable.
  - SECT. 4. The first item of section fifty-four of said 2 chapter is amended, by striking out all after the word

- 3 county in the sixth line, so that said item as amended
- 4 shall read as follows:
- 5 First—They shall appoint suitable times and places
- 6 for the examination of candidates proposing to teach
- 7 in town, and give notice thereof by posting the same
- 8 in two or more public places within the town at least
- 9 three weeks before the time of said examination, or
- 10 the publication for a like length of time of said notice
- 11 in one or more of the newspapers having the largest
- 12 circulation in the county.
  - Sect. 5. The second item of section sixty of said
  - 2 chapter, is amended, so as to read as follows:
  - 3 Second—To employ teachers, to provide fuel and
  - 4 utensils necessary for the school, and make repairs
  - 5 upon the school-houses and out-buildings, and procure
  - 6 insurance of the same, if the district so direct; but no
  - 7 more than one-tenth of the money apportioned to the
  - 8 district shall be expended for such repairs in one year,
  - 9 exclusive of fuel and insurance; and he shall, before
- 10 the commencement of a term of school, give written
- 11 notice to some member of the superintending school
- 12 committee, or supervisor, when it is to commence,
- 13 whether to be kept by a master, or mistress, and how
- 14 long it is expected to continue, seven days, at least,
- 15 before the commencement; and in the absence of any

- 16 agreement to the contrary, five and one-half days shall 17 constitute the school week, and four weeks shall con-
- 18 stitute the school month.

SECT. 6. This act shall take effect when approved.
