STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SEVENTY-ONE.

AN ACT to promote immigration and facilitate the settlement of the public lands.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- SECTION 1. There shall be a board of immigration
- 2 in this state, composed of the governor, secretary of
- 3 state and land agent.
 - SECT. 2. It shall be the duty of said board to
- 2 appoint a commissioner of immigration, an agent
- 3 resident in Sweden, and an agent resident in New
- 4 Sweden, Maine, and to exercise a general supervision
- 5 over the expenditure of all money appropriated by this 6 act.
 - SECT. 3. It shall be the duty of said commissioner
- 2 to collect statistics and other useful information con-

- 3 cerning the climate, soil, productions and resources of 4 the state, the amount and location of unsettled lands 5 in Maine, the terms offered by the state to settlers, 6 together with the condition and progress of the colony 7 at New Sweden, and such other information as he may 8 deem proper, and cause the same to be translated into 9 the Swedish language and distributed in Sweden and
- 10 the United States, in such manner as may be deemed
- 11 desirable and best calculated to promote the provisions
- 12 of this act, provided the whole amount expended for
- 13 this purpose shall not exceed the sum of one thousand 14 dollars.
- SECT. 4. It shall be the further duty of said com2 missioner to exercise a general care and oversight over
 3 all immigrants coming to Maine, to give them all
 4 needful information, to assist them in settling upon the
 5 public lands of the state, or obtaining employment
 6 within its borders, and to have special charge of the
 7 colony at New Sweden, to the end that its develop8 ment and prosperity may be promoted in every way
 9 consistent with law; and the compensation and entire
 10 expenses of said commissioner shall not exceed the
 11 sum of twenty-five hundred dollars.
 - SECT. 5. The first agent provided for in section 2 second of this act shall reside in Gothenburg, Sweden; 3 shall have charge of the printing, and of the dis-

- 4 tribution throughout Sweden of all documents and
- 5 information to be furnished him by the commissioner;
- 6 shall use his best endeavors in every lawful way to
- 7 encourage emigration to Maine, to protect the emi-
- 8 grants from fraud and imposition, and to enable them
- 9 to embark from Sweden with proper guarantees for
- 10 their safety and comfort on their passage and with
- 11 suitable information to the Swedish colony of our
- 12 state; and the compensation of said agent shall not
- 13 exceed the sum of five hundred dollars.
 - Sect. 6. The second agent provided for in section
 - 2 second of this act shall reside in New Sweden, shall
 - 3 have special charge of the state store-house, stores,
 - 4 tools and all other state property there, shall receive
 - 5 and disburse all state supplies and keep proper ac-
- 6 counts and vouchers therefor; and the compensation
- 7 of said agent shall not exceed the sum of two hundred
- 8 dollars.
- SECT. 7. The agents mentioned in the two pre-
- 2 ceding sections shall perform their duties under the
- 3 direction of the commissioner of immigration.
 - SECT. 8. The board aforesaid may, if in their opinion
- 2 the circumstances require it, expend amounts not ex-
- 3 ceeding the following sums, for the several purposes
- 4 hereinafter enumerated: For provisions and tools to
- 5 be sold the colonists at cost, and for which payment

6 may be taken in labor, at one dollar a day, on the 7 roads, public buildings, and other public works, five 8 thousand dollars; for finishing and furnishing the pub-9 lic building at New Sweden, one thousand dollars; 10 for seed, five hundred dollars; for roads, five hundred 11 dollars; for schools and school books, three hundred 12 dollars; for all other purposes to promote the pro-13 visions and spirit of this act, five hundred dollars.

SECT. 9. The board aforesaid may cause all immi-2 grants arriving under the provisions of this act to be 3 settled on any of the public lands of the state not 4 otherwise appropriated, and assign to each man over 5 twenty-one years of age by certificate from the land 6 agent, a lot of one hundred acres of land; and the 7 land agent shall, at the expiration of five years from 8 the date of said assignment, grant each of the persons 9 aforesaid or their heirs at law, a deed of warranty or 10 other valid title of the lot assigned him; provided each 11 of said persons has established his residence on the lot 12 assigned him, has built him a comfortable house there-13 on, and has cleared not less than fifteen acres of land 14 within the time aforesaid, ten of which shall be laid 15 down to grass; and all said persons shall be exempt 16 from state taxation until January first, A. D. eighteen 17 hundred and seventy-six.

SECT. 10. The governor is hereby authorized to

- 2 draw his warrant upon the treasurer for any of the 3 sums specified in this act.
 - Sect. 11. All acts and parts of acts inconsistent
- 2 with this act are hereby repealed, and this act shall
- 3 take effect when approved.
