# STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SEVENTY-TWO.

---

AN ACT to re-annex a part of Limerick to Limington.

---

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

SECTION 1. So much of the territory of the town of  
2 Limington, with the inhabitants and their polls and  
3 estates, as was set off from said Limington by act of  
4 the legislature approved March second, A. D. eighteen  
5 hundred and seventy, and annexed to the town of  
6 Limerick, is hereby re-annexed to said Limington, so  
7 as to restore the dividing line between said towns to  
8 its original location.

SECT. 2. The inhabitants and estates so set back,  
2 shall be held to pay all arrears of taxes which have  
3 been legally assessed on them ; and the same may be  
4 collected by the same officers as if this act had not  
5 been passed.

SECT. 3. The town of Limington is authorized to  
2 assume and pay to the town of Limerick, the sum of

3 eight hundred dollars, with interest thereon from the  
4 first day of March, A. D. eighteen hundred and seven-  
5 ty, to reimburse said town for the eight hundred dol-  
6 lars and interest paid by it to the town of Limington  
7 under the act aforesaid, and may raise money there-  
8 for the same as for other town purposes ; and this act  
9 shall not take effect unless, on or before the twentieth  
10 day of March next, the town of Limington, or some  
11 citizens thereof, shall pay or tender, in United States  
12 legal tender notes, to the treasurer of the town of  
13 Limerick, the amount aforesaid, and if so paid or ten-  
14 dered, it shall then take effect.

SECT. 4. The sum of forty-five thousand four hun-  
2 dred and twenty-four dollars is hereby deducted from  
3 the state valuation of the town of Limerick and added  
4 to the valuation of the town of Limington.

SECT. 5. This act shall take effect when approved,  
2 except as provided in section three hereof.
