The Joint Special Committee on Temperance, which was instructed by an order of the Legislature to inquire into the expediency of amending section twenty-two of chapter sixty-three of the public laws of eighteen hundred and seventy-two, in relation to the sale of cider, have had the same under consideration, and ask leave to report the accompanying bill.

STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SEVENTY-THREE.

AN ACT amendatory of chapter sixty-three of the public laws of eighteen hundred and seventy-two, and of chapter twenty-seven of the revised statutes, relating to intoxicating liquors.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- SECT. 1. Section two of chapter sixty-three of the 2 public laws of eighteen hundred seventy-two is hereby 3 repealed.
- SECT. 2. Section twenty-five of chapter twenty-
- 2 seven of the revised statutes, as amended by section
- 3 three of chapter sixty-three of the public laws of
- 4 eighteen hundred seventy-two, is hereby amended by
- 5 striking out the words "and sale of unadulterated
- 6 cider by the manufacturer, nor to the sale by agents
- 7 appointed under the provisions of this chapter, of pure
- 8 wine," and inserting instead the words, 'of unadul-
- 9 terated cider, nor to the sale thereof except when sold

- 10 to be drank on the premises; nor to the manufacture
- 11 and sale by the manufacturer of pure wine made from
- 12 fruit grown in this state,' so that said section, as
- 13 amended, shall read as follows:
- 14 Sect. 25. The provisions of this chapter shall not
- 15 extend to the manufacture of unadulterated cider, nor
- 16 to the sale thereof except when sold to be drank on
- 17 the premises; nor to the manufacture and sale by the
- 18 manufacturer of pure wine made from fruit grown in-
- 19 this state, for sacramental and medicinal uses.

 - SECT. 2. Section twenty-five of chapter twenty-
- 2 seven of the revised statutes is hereby amended so as
- 3 to read as follows:
- 4 Sect. 25. The provisions of this chapter shall not
- 5 extend to the manufacture and sale to agents ap-
- 6 pointed under the provisions of this chapter of pure
- 7 wine made from fruit grown in this state, and said
- 8 agents-may sell the same in the same manner and for
- 9 the same purposes that they are now authorized to
- 10 sell malt and distilled liquors.
