RESOLVES

Appropriating money, passed by the Legislature of 1873, together with the object and amount of each appropriation.

- CH. 2. Resolve providing for purchase of Maine State Year Book; 800 copies to be provided not exceeding \$1.25 per copy. Approved January 25.
- CH. 5. Resolve in favor of city of Hallowell. Amount of appropriation \$190.66, for clerical error in apportionment of school fund and mill tax. Approved February 1.
- CH. 7. Resolve in aid of building road in township F, R. 1, in Aroostook county; \$500 to be expended by Land Agent. Approved February 1.
- CH. 8. Resolve in favor of Peter Sepsis; \$100 for services as Representative of Passamaquoddy Tribe of Indians. Approved February 4.
- CH. 11. Resolve in favor of Charles A. Chase; \$315.20 for timber cut on his land, lot No. 47, township C, R. 5, W. E. L. S. Approved February 4.
- CH. 12. Resolve in favor of John Gabriel; \$25.00 for expenses as contestant as Representative Passamaquoddy Tribe. Approved February 4.
- CH. 13. Resolve in favor of town of Lyndon; \$5.00 in bounty on animals, not allowed in 1872. Approved February 6.
- CH. 16. Resolve in aid of a road in Crystal Plantation; \$650 to be expended by Land Agent building and repairing road. Approved Feb. 11.
- CH. 17. Resolve in favor of the Bangor Childrens' Home; \$1000 to be paid to trustees. Approved Feb. 11.

- CH. 18. Resolve in favor of Charles S. Page; \$300 for support of said Page in Perkins' Institute. Approved Feb. 11.
- CH. 20. Resolve in favor of Charles W. Cobb; \$8.00 per month granted in addition to pension of \$12 heretofore granted him. Approved Feb. 14.
- CH. 21. Resolve in favor of a road in the town of Mt. Chase; \$500 for repair of road under direction of Land Agent. Approved Feb. 14.
- CH. 22. Resolve in favor of a road leading from Monson to Greenville in the town of Shirley; \$300 to be expended under direction of selectmen. Approved Feb. 14.
- CH. 19. Resolve in aid of repairing the road through Long Swamp in the town of Littleton; \$1000 to be expended under direction of the Land Agent. Approved Feb. 14.
- CH. 24. Resolve in favor of Samuel C. Niles; \$100 as bounty to said Niles, a private, Co. B, 11th Regt. Me. Vols. Approved February 14.
- CH. 31. Resolve providing for surveying and marking the line between Maine and New Hampshire; expense to be paid by State, but no amount specified. Approved Feb. 17.
- CH. 34. Resolve in favor of John Gaubriel; \$32.00 for prevention of small pox in Passamaquoddy tribe. Approved Feb. 17.
- CH. 35. Resolve in favor of the Joint Standing Committee on the State Prison; \$105.50 paid to Henry H. Burgess for expense of visit of said Committee to State Prison. Approved Feb. 17.
- CH. 36. Resolve providing for payment of the expenses of the Committee on Military Affairs; \$50.00 paid to Wm. E. Hadlock for expense of Committee's visit to Bath Asylum. Approved Feb. 17.
- CH. 37. Resolve in favor of Henry F. Eaton, Charles H. Eaton and T. W. Baldwin; \$724.53 to be paid Eaton and others for expense of survey of township No. 7, R. 9, north of Waldo Patent, purchased by them of State. Approved Feb. 17.

RESOLVES APPROPRIATING MONEY.

- CH. 38. Resolve in favor of inhabitants of Eagle Island Military plantation, county of Hancock; \$433.33 to reimburse the inhabitants of Eagle Island for money expended by them in war of 1861. Approved Feb. 19.
- CH. 42. Resolve in favor of county of Aroostook; \$100 to refund treasury of Aroostook for money expended by County Commissioners in repairing roads on State lands in 1872. Approved Feb. 19.
- CH. 44. Resolve in favor of Annie O. Burnham; \$8.00 per month granted as a pension from Jan. 1, '73, during pleasure of Legislature. Approved Feb. 19.
- CH. 46. Resolve in favor of appropriating money for repair of bridge over Mattawamkeag river in Haynesville; \$350 for repair of said bridge by Land Agent. Approved Feb. 21.

RESOLVES ENGROSSED BUT NOT YET APPROVED.

- Resolves in aid of building bridges in Hamlin plantation, Aroostook; \$400 under direction of Land Agent.
- Resolve in aid of road over Indian township in Washington county; \$800 under direction of Land Agent.
- Resolve in favor of Walker Darling; \$4 per month for pension from January 1, 1873.
- Resolve making appropriation for the propagation of fish and for additional fish wardens; \$500 under direction of Fish Commissioners.
- Resolve in favor of Woodland plantation; \$126 for school fund.
- Resolve in favor of the State Library; 100 copies each of vols. 10, 11 and 12, Maine Reports not exceeding \$4 per volume.
- Resolve in favor of repairing and rebuilding bridges over streams between Patten and Chamberlain Lake; \$500 under supervision of Land Agent.
- Resolve in favor of Military and Naval Asylum at Bath; \$10,000 under direction of Governor and Council.

Resolve in favor of the State Prison; \$8000—\$5000 for steam fire engine and hose, and \$3000 for completion of wall on west side of prison yard.

Resolve in favor chapel of Insane Hospital; \$500 for stained glass for said chapel contracted for in 1871 and delivered in 1872.

Resolve in favor of W. J. Corthell \$97.50 for visit to Western Normal School.

Resolve in favor of bridge in Cape Elizabeth; \$2,500 to be expended on said bridge.

Resolve in favor of Joseph Nicolar; \$100 for services as Representative of Penobscot Indians.

Resolve in favor of Passamaquoddy Tribe of Indians; \$38.20 for sundry expenses of said Tribe.

Resolve in favor of Penobscot Indians; \$8,909.70 to be expended for said Tribe.

Resolve appropriating money to be expended in repairing bridge over Moluncus stream; \$2000 under direction of the Land Agent.

Resolve for payment of bounties on wild animals; \$1,555.

Resolve in favor of town of Kingsbury; \$500 to be expended by Land Agent upon "New England" road.

Resolve in favor of Industrial School for Girls; \$5,000.

Resolve in relation to industrial statistics; \$1,000 for statistical information.

Resolve in favor of Committee on Agriculture; \$114.50 expense of said Joint Standing Committee's visit to Orono.

Resolve in favor of opening a road in Castle Hill plantation.

Resolve in aid of building bridges in Chapman plantation; \$300 for said bridges.

Resolve in aid of building a road from Kingfield to Eustis in Franklin county; \$500.
