## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SEVENTY-FOUR.

AN ACT providing for taxation of railroad and insurance companies.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. That all railroad corporations doing

- 2 business in this state shall hereafter pay to the state,
- 3 for its use, a tax on all their property, real and per-
- 4 sonal, including their track, franchise and equipment,
- 5 at the same rate as is assessed by the state on other
- 6 property for state revenue of the year, and upon a
- 7 valuation to be annually made by the railroad commis-
- 8 sioners, which valuation shall be so made as to include
- 9 the true value of the road for its entire length in the
- 10 state, taking into consideration its franchise, its busi-
- 11 ness, its property, and all other matters bearing upon

- 12 the question, but making no deduction for debts or
- 13 incumbrances. When the road extends into other
- 14 states or provinces the entire road shall be so valued,
- 15 and a proportionate part thereof apportioned to Maine
- 17 according to the relative length or miles of main track;
- 18 the tax so assessed to be in full of all taxes, both on
- 19 their property and on the shares of stockholders.

Sect. 2. Such tax shall be assessed on or before the

- 2 first day of April of each year by the governor and coun-
- 3 cil, prior to which time the railroad commissioners shall
- 4 seasonably certify to them their valuation, as provided
- 5 for in the previous section; and upon such assessment
- 6 being made the secretary of state shall certify the
- 7 same to the state treasurer, who shall thereupon notify
- 8 the respective companies thereof, the tax to be paid,
- 9 one-half on the first day of July then next, and the
- 10 balance on the first day of January then next. And
- 11 if said taxes are not so paid the treasurer shall issue
- 12 his warrant for their collection in manner provided
- 13 for other cases of unpaid taxes, directing the same to
- 14 the several sheriffs of the counties and their deputies.
- 15 And upon said warrants any engines, cars, or other
- 16 personal property of the corporation may be taken and
- 17 sold without regard to any incumbrances thereon here-
- 18 after made.

SECT. 3. That all insurance companies doing busi-

- 2 ness in this state, foreign and domestic, except domes-
- 3 tic mutual fire companies, shall hereafter pay to the
- 4 state for its use a tax of one per cent. on all premiums
- 5 received during the year ending on the thirty-first day
- 6 of December next previous, which tax shall be assessed
- 7 by the governor and council upon the certificate of the
- 8 insurance commissioner, to be seasonably furnished on
- 9 or before the first day of April, and upon such assess-
- 10 ment being made the secretary of state shall certify
- 11 the same to the state treasurer for collection, the same
- 12 to be paid on or before the first day of May then next.
- 13 And it shall be the duty of the treasurer upon receiv-
- 14 ing the secretary's certificate to notify the several com-
- 15 panies of the assessment, and unless the same be paid
- 16 as aforesaid the commissioner shall suspend the right
- 17 of the company to do any further business in the state
- 18 until the tax is paid.
