## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SEVENTY-FOUR.

AN ACT to make the thirtieth day of May a legal holiday.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. Section nine of chapter thirty-two, is 2 hereby amended, by adding after the word "January" 3 in the seventh line, the words, 'thirtieth day of May,' 4 so that the said section, as amended, shall read as 5 follows:

6 "On any promissory note, inland bill of exchange, 7 draft, or order for the payment of money, payable in 8 in this state at a future day, or at sight and not on 9 demand, a grace of three days shall be allowed, if the 10 third day is Sunday, a day of public fast or thanks-11 giving appointed by the governor and council, the

12 fourth day of July, the twenty-second day of Febru-13 ary, or Christmas, or first day of January, or the 14 thirtieth day of May, two days shall be allowed. If 15 the fourth day of July, twenty-second day of February, 16 Christmas, first day of January, or thirtieth day of 17 May, is Monday, and it is the third day of grace, or 18 is Saturday and the following Sunday is the third day 19 of grace, four days shall be allowed."

SECT. 2. Section eighteen of chapter seventy-seven, 2 is hereby amended, by adding after the word "Sep-3 tember" in the second line, the words, 'the thirtieth 4 day of May, so that said section, as amended, shall 5 read as follows:

6 "No court shall be held on Christmas day, the fourth 7 day of July, second Monday of September, thirtieth 8 day of May, or any day designated for choice of presi-9 dent and vice president of the United States, or for 10 the annual fast or thanksgiving; and when the time 11 fixed for a term of said court fall on either of said 12 days it shall stand adjourned until the next day, which 13 shall be deemed the first day of the term for all pur-14 poses."

SECT. 3. Section seventy-six of chapter eighty-one, 2 is hereby amended, by adding after the words "thanks-3 giving" in the third line, the words, 'thirtieth day of 4 May,' so that said section, as amended, shall read as 5 follows:

6 "No person shall be arrested in a civil action, or 7 mesne process, or execution, or on a warrant for taxes, 8 on the fourth day of July, Christmas day, or the day 9 of annual fast, thanksgiving, or thirtieth day of May; 10 and no officer or soldier, who is required by law to 11 attend a military training, inspection, review or elec-12 tion, shall be arrested on any such process on such 13 day."

SECT. 4. This act shall take effect when approved.
