## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SEVENTY-FIVE.

[S. 25.] AN ACT to secure the education of youth in the State of Maine.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. That every parent, guardian, or other

- 2 person in the State of Maine, having control of any
- 3 child or children between the ages of seven and four-
- 4 teen years, shall be required to send such child or
- 5 children to a public school for a period of at least
- 6 twelve weeks in each year, unless such child or child-
- 7 ren are excused from such attendance by the school
- 8 officers of the town in which such parent or guardian
- 9 resides, upon its being shown to their satisfaction that
- 10 the mental or bodily condition of such child or children
- 11 has been such as to prevent attendance at school or
- 12 application to study for the period required, or that

13 such child or children have been taught at a private 14 school or at home in such branches as are usually 15 taught in primary schools; provided in case a public 16 school shall not be taught for three months in the year 17 within one and one-half miles by the shortest travelled 18 road of the residence of such delinquent, he shall not

19 be liable to the provisions of this act.

- SECT. 2. In case any parent, guardian, or other 2 person having such control, shall fail to comply with 3 section one of this act, he shall be liable to a fine not 4 exceeding five dollars and costs of prosecution for such 5 offence, to be recovered in any court competent to try 6 the same, and the magistrate or court to which said 7 fine shall be paid shall pay the same to the treasurer 8 of the town in which the offence was committed, and 9 shall be by him accounted for the same as money 10 raised for school purposes.
  - Sect. 3. Every boy in this state between the ages 2 of seven and fourteen years, who shall neglect or re-3 fuse to attend school as required in section one of this 4 act, unless excused by the school officers of the city, 5 town or plantation in which he resides, on being con-6 victed of such offence, shall pay a fine not exceeding 7 five dollars, or be sentenced to the reform school, in 8 the discretion of the court or magistrate before whom 9 the offence is tried.

SECT. 4. It shall be the duty of the school commit-

- 2 tee or town supervisor to enforce the several provisions
- 3 of this act.
