STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SEVENTY-FIVE.

[S. 46.] AN ACT to repeal chapter three hundred and fourteen of the resolves of eighteen hundred seventyfour, and to revive all acts and parts of acts repealed by said chapter three hundred and fourteen of the resolves of eighteen hundred seventy-four, and to amend section four of chapter five of the revised statutes.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. Chapter three hundred and fourteen of 2 the resolves of eighteen hundred and seventy-four is 3 hereby repealed, and all statutes and parts of statutes 4 relating to the land agent or land office in force at the 5 passage of said resolve, are hereby revived.

SECT. 2. Chapter five, section four of the revised 2 statutes, is hereby amended by striking out the letter

3 "s" in the word "officers" in the eighteenth line of said
4 section, and by striking out the words "and Bangor"
5 in the nineteenth line of said section, and by striking
6 out the words "either of" in the twentieth line of said
7 section, and by striking the letter "s" out of the word
8 "officers" in the twentieth line of said section, so that
9 said section as amended shall read as follows :

All the public lands, where not otherwise 10Sect. 4. 11 specially provided, shall be managed and sold under 12 the direction of the governor, council, state treasurer 13 and the land agent, for the time being; and they are 14 constituted a board for that purpose, and shall make 15 return of their doings to each regular session of the 16 legislature; and the governor, state treasurer and land 17 agent, in the absence of the council shall constitute a 18 quorum for the transaction of the business hereby con-19 fided to them. Said board shall, from time to time, 20 cause all lands suitable for settlement to be surveyed 21 into lots of one hundred and sixty acres each, and 22 cause a minimum price to be noted on each lot. An 23 accurate plan or map of all lands surveyed shall be 24 returned to the land office, and entered upon the plan 25 books within three months after the survey is com-26 pleted, on which shall be laid down all lakes, ponds, 27 rivers, streams, falls, mill sites, and roads. The field 28 notes of such surveys shall contain a description of the 29 growth, soil, and general character of the township, 30 and of every lot, if it is surveyed into lots, which shall 31 be deposited in the land office within three months. 32 The said plans and field notes shall be kept at the 33 office in Augusta, open for inspection at all times, 34 when the land agent or his assistant is in said office, 35 and he shall aid in furnishing information about the 36 public lands to all persons who seek for it at his office.
