STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SEVENTY-SIX.

AN ACT to amend chapter two hundred and thirty-nine of the public laws of eighteen hundred and seventy-four.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. No person shall kill or expose for sale,

- 2 or have in his or her possession after the same has been
- 3 killed, any woodcock, or ruffed grouse, commonly
- 4 called "partridge," except during the times and for
- 5 the purposes hereinafter mentioned, namely: Any per-
- 6 son may, for the purpose of consumption as food within
- .7 this state, lawfully kill, expose for sale, or have in
 - 8 possession, any woodcock between the fourth day of
 - 9 July in any year and the first day of December follow-
- 10 ing, both days inclusive; or any ruffed grouse between
- 11 the first day of September in any year and the first
- 12 day of December following, both days inclusive.

- SECT. 2. No person shall kill, or expose for sale, or 2 have in possession, except alive, at any time, any 3 woodcock or ruffed grouse with the intention of send-4 ing or transporting, or of having the same sent or 5 transported beyond the limits of this state, under a 6 penalty of not less than five nor more than ten dollars 7 for each woodcock or ruffed grouse thus killed, exposed 8 for sale, or had in possession.
- SECT. 3. Section one of chapter two hundred and 2 thirty-nine of the public laws of eighteen hundred and 3 seventy-four, is hereby amended by striking out all of 4 said section after the words "section one," and insert-5 ing in the place thereof the following words, viz: "No person shall kill or have in his possession, except 7 alive, or expose for sale any wood-duck, English snipe, 8 or woodcock between the first day of December and 9 the fourth day of July following; or kill any ruffed 10 grouse, commonly called 'partridge,' between the first 11 day of December and the first of day September follow-12 ing, or have the same in possession, except alive, or ex-13 pose for sale, between the fifth day of December and first 14 day of September following; or kill, sell, or have in 15 possession, except alive, any quail or pinnated grouse, 16 commonly called 'prairie chicken,' between the first 17 day of January and the first day of September follow-18 ing, under a penalty of not less than five no more than

- 19 ten dollars for each bird so killed, or had in possession,20 or exposed for sale."
 - SECT. 4. Sections four and five of chapter two hun-
 - 2 dred and thirty-nine, of the public laws of eighteen
 - 3 hundred and seventy-four, are hereby made applicable
 - 4 to this act, the same as they would have been had the
 - 5 preceding sections of this act been incorporated in said
 - 6 act of eighteen hundred and seventy-four, between the
 - 7 sections therein numbered four and five.
