STATE OF MAINE.

RESOLVE amendatory to chapter twenty of resolves of
eighteen hundred seventy-five, entitled "resolve in
favor of Crystal plantation in county of Aroostook."

Resolved, That chapter twenty of the resolves of eight-
2 teen hundred seventy-five, entitled "resolve in favor
3 of Crystal plantation in county of Aroostook," be
4 amended by striking out the words "as above indi-
5 cated, thirty" in the thirteenth line, and inserting in
6 place thereof the words "twenty-six," so that the
7 resolve as amended shall read as follows :

8 *Resolved*, That there be appropriated from the state
9 treasury to Crystal plantation, in the county of Aroos-
10 took, the sum of two thousand and five hundred dol-
11 lars, under the following restrictions, limitations and
12 conditions, namely : that if during the year eighteen
13 hundred and seventy-five the plantation of Crystal
14 shall cut out and grub the Molunkus Valley road, as

15 laid out by the commissioners of Aroostook county,
16 through its whole length in said plantation, and of suf-
17 ficient width to construct a turnpike road thirty feet in
18 width the entire distance in said plantation, then said
19 plantation shall receive the sum of twelve hundred and
20 fifty dollars ; and if said plantation shall, during the
21 years eighteen hundred and seventy-six and seven, in-
22 clusive, construct a good and sufficient turnpike road
23 therein, twenty-five feet in width, with all the requi-
24 site bridges and culverts in its entire length in said
25 plantation, to the acceptance of the land agent or other
26 person appointed by the governor for said purpose,
27 then, upon completion of said road, said plantation
28 shall receive a further sum of twelve hundred and
29 fifty dollars, the whole of which sum the governor is
30 authorized and required to draw his warrants for, in
31 the manner and time therein prescribed, and this sum
32 shall be in full for the construction of said road through
33 said plantation.
