STATE OF MAINE.

RESOLVE in favor of Charles F. Collins.

Resolved, That the land agent be authorized to convey to Charles F. Collins lot number thirty-eight in township L, range two, and also lot number twenty-four in township number eleven, range three, Aroostook county, on payment by said Collins, in addition to the road labor already paid, of twenty cents per acre in cash and proving that he is the lawful owner of the land certificates of said lots.

STATEMENT OF FACTS:

To the Hon. Senate and House of Representatives in Legislature assembled, for 1878:

The subscriber would respectfully represent to your honorable body, that he is the owner of a certificate from the State for lot No. 24, in township eleven, range 3, (11 x 3) in Aroostook county, and that the amount of road work required has been performed; that the said lot is not suitable for a homestead or farm, and having invested as much in said lot as it is worth, would respectfully ask your honorable body to pass a resolve authorizing the State Land Agent to give your petitioner a deed, waiving all further settling duties.
