## STATE OF MAINE.

---

RESOLVE making appropriations for the Penobscot tribe  
of Indians.

---

*Resolved,* That there be paid from the state treasury  
2 to the agent of the Penobscot tribe of Indians, to be  
3 appropriated for the benefit of the said tribe, as follows :  
4 forty-four hundred twenty-nine dollars and seventy  
5 cents, amount of interest on their trust fund, held by  
6 the state for the benefit of said tribe ; eighteen hun-  
7 dred dollars for their annual annuity ; eight hundred  
8 dollars for agricultural purposes ; four hundred dollars  
9 for bounty on crops ; three hundred dollars for salary  
10 of agent ; one hundred and fifty dollars to pay com-  
11 petent persons, to be employed by the agent, to assist  
12 and instruct said indians in their agricultural labors,  
13 as follows : seventy-five dollars on Oldtown and Orson  
14 islands, thirty-seven dollars and fifty cents on Hem-

15 lock, Sugar and Olamon islands, thirty-seven dollars  
16 and fifty cents on Mattanawcook island, on the same  
17 conditions as required by chapter ninety-six of the re-  
18 solves of eighteen hundred and sixty-seven ; four hun-  
19 dred and fifty dollars for schools, to be used in employ-  
20 ing competent teachers, viz : two hundred and fifty  
21 dollars on Oldtown island, under the supervision of the  
22 superintending school committee of Oldtown, one hun-  
23 dred dollars on Olamon island, under the supervision  
24 of the superintending school committee of Greenbush,  
25 one hundred dollars on Mattanawcook island, under the  
26 supervision of the superintending school committee of  
27 Lincoln ; and said committees are required to report,  
28 as directed in resolve approved March seventeen, eigh-  
29 teen hundred and sixty ; and it is the duty of said  
30 agent to see that the money is fully expended for the  
31 education of the children of said tribe ; one hundred  
32 dollars for salary of their priest, provided he says mass  
33 at least twenty-four Sundays during the year with said  
34 tribe of indians ; fifty dollars for salary of their gov-  
35 ernor ; fifty dollars for salary of their lieutenant gov-  
36 ernor ; fifty dollars for repairs on their schoolhouse on  
37 Mattanawcook island. All the abovenamed sums to be  
38 paid under the direction of the governor and council.
