## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SEVENTY-EIGHT.

AN ACT to amend chapter three hundred and sixtythree of the special laws of eighteen hundred and seventy-seven, relating to the throwing of refuse into the Piscataquis river.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

The act entitled "an act to prevent the throwing of

- 2 refuse wood, timber or fibrous materials created by the
- 3 sawing of lumber into the Piscataquis river," being
- 4 chapter three hundred and sixty-three of the special
- 5 laws of eighteen hundred and seventy-seven, is hereby
- 6 amended by inserting after the word "river" in the
- 7 first line, and before the word "any" in the second
- 8 line, the words, "or any of its tributaries above the

9 town of Dover," and by inserting after the word 10 "river," and before the word "in," in the sixth line, 11 "or any of its tributaries above the town of Dover," 12 and also by inserting the same words after the word 13 "river," and before the word "or," in the fourteenth 14 line, so that said act as amended shall read as follows: 15 "No person shall cast or throw into the Piscataquis 16 river or any of its tributaries above the town of Dover, 17 any slabs, boards or lath edgings, bark, grindings of 18 edgings, wood or bark, or any refuse wood or lum-19 ber of any kind, or any shavings or fibrous materials 20 created by the sawing of lumber; or shall place, pile 21 or deposit the same on the banks of said river, or any 22 of its tributaries above the town of Dover, in such 23 negligent or careless manner that portions thereof may 24 fall or be washed into said river, whereby the flumes 25 of mills and manufacturing establishments upon said 26 river may be filled up or injuriously affected, or the 27 water wheels thereof may be impeded or injuriously 28 affected, under a penalty for each offence, if the quan-29 tity shall not exceed five cords, of not less than five, 30 or more than twenty dollars; and if the quantity cast 31 or thrown into said river, or any of its tributaries 32 above the town of Dover, or which shall fall or be

- 33 washed in, as aforesaid, shall exceed five cords, under
- 34 a penalty of not less than twenty, nor more than five
- 35 hundred dollars.
