## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SEVENTY-EIGHT.

AN ACT to incorporate the Kennebec Association for the protection of fish and game.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. George W. Martin, S. A. Russell,

12 of Gardiner, and Stephen W. Carr of Bowdoinham,
13 their associates, successors and assigns, are hereby
14 created a body politic and corporate by the name of
15 the "Kennebec Association for the protection of fish
16 and game," for the purpose of aiding in the enforce17 ment of the laws of the state for the protection of fish
18 and game, and promoting the study of natural history,
19 with power, for such purpose, to take by purchase,
20 bequest or otherwise, and to hold and convey, real
21 and personal property to the amount of ten thousand
22 dollars.

Sect. 2. Said corporation shall have power by that 2 name to prosecute and defend suits at law and in 3 equity, to enter and prosecute complaints against any 4 person or persons for violating any law of the state 5 for the protection of fish and game, and to recover and 6 receive all penalties and forfeitures that would be 7 recoverable by any person making such complaints; 8 to have and use a common seal, and adopt a code of 9 by-laws, not inconsistent with the laws of the state, 10 for the due and orderly management of its officers, Il and for the raising of money from its members by 12 assessments and fines, for the admission of new mem-13 bers, for the expulsion of any members for the breach 14 of such by-laws, and for such other purposes as may 15 seem necessary.

SECT. 3. The first meeting of said corporation may

- 2 be called by any three of the corporators, by a notice
- 3 specifying the time and place for such meeting, pub-
- 4 lished in any paper in the city of Augusta, at least
- 5 one week prior to the time fixed for the meeting.

SECT. 4. This act shall take effect when approved.
