STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND SEVENTY-NINE.

AN ACT to amend chapter sixty-six of the public laws of eighteen hundred and seventy-eight, relating to the shore fisheries.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Section one of chapter sixty-six of

- 2 the public laws of the year eighteen hundred and
- 3 seventy-eight is hereby amended, by striking out
- 4 the words "one mile in width," in the sixth line of
- 5 said section, and by inserting in place thereof the
- 6 following words, viz: "two nautical miles in width,
- 7 and such taking or fishing therefor is also hereby
- 8 prohibited in any of the waters within one nautical
- 9 mile of the coast or of any inhabited island within
- 10 the jurisdiction of this state;" so that as amended
- 11 said section shall read as follows:

12 Sect. 1. The taking of mackerel, herring or por-13 gies or menhaden, or fishing therefor by the use of 14 purse and drag seines, is hereby prohibited in all 15 of the small bays, inlets, harbors or rivers of this 16 state, where any entrance to the same, or any part 17 thereof, from any land to land is not more than two 18 nautical miles in width; and such taking or fishing 19 therefor is also hereby prohibited in any of the 20 waters within one nautical mile of the coast or of 21 any inhabited island within the jurisdiction of this 22 state, under a penalty upon the master or person 23 in charge of such seine or seines of not less than 24 one hundred nor more than three hundred dollars, 25 and there shall be a lien upon the vessels, steamers, 26 boats and apparatus used in such unlawful pursuit 27 until said penalty is paid; but a net for meshing 28 mackerel or porgies, of not more than one hundred 29 meshes in depth, and a net for meshing herring, of 30 not more than one hundred and seventy meshes in 31 depth, shall not be deemed a seine.

SECT. 2. This act shall take effect on and after 2 the twenty-first day of February, eighteen hundred 3 and seventy-nine.
