STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND.

AN ACT amendatory of and additional to section two, chapter sixty-five of the public laws of eighteen hundred and seventy-six.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- SECTION 1. Section two of chapter sixty-five of
- 2 the public laws of eighteen hundred and seventy-
- 3 six is hereby amended by inserting after the word
- 4 "act" in the second line the words "or section
- 5 eighteen, chapter forty-eight of the revised stat-
- 6 utes," and striking out the word "two" where it
- 7 occurs in the third line and inserting in place
- 8 thereof the word "one"; also by adding thereto
- 9 the words "and the acts of all companies heretofore
- 10 formed under the provisions of law relating to the

- 11 organization of business corporations in fixing the
- 12 amount of capital stock at a sum not over five
- 13 hundred thousand dollars are hereby declared valid,
- 14 if otherwise organized, according to law," so that
- 15 said section shall read as follows:
- 16 Sect. 2. All companies organized under the pro-
- 17 visions of this act or section eighteen, chapter
- 18 forty-eight of the revised statutes, shall fix the
- 19 amount of their capital stock which shall not be
- 20 less than one thousand dollars nor more than five
- 21 hundred thousand dollars, and the acts of all com-
- 22 panies heretofore formed under the provisions of
- 23 law relating to the organization of business cor-
- 24 porations in fixing the amount of capital stock in
- 25 a sum not over five hundred thousand dollars are
- 26 hereby declared valid if otherwise organized ac-
- 27 cording to law. Chapter one hundred thirty-three
- 28 of the public laws of eighteen hundred and seventy-
- 29 nine, entitled an act to amend chapter forty-eight
- 30 of the revised statutes relative to corporations
- 31 under the general laws is hereby repealed.

Sect. 3. This act shall take effect when approved.
