## STATE OF MAINE.

AN ACT to amend section six, chapter seventy-eight of the revised statutes, in relation to the time of meeting of the county commissioners of Washington county.

---

*Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :*

Section six of chapter seventy-eight of the revised  
2 statutes is hereby amended by striking out in the  
3 thirty-first and thirty-second lines of said section  
4 the words "the first Wednesday next after," and  
5 in the thirty-third line the words "the first Wed-  
6 nesday next after," so that said section as amended  
7 shall read as follows:

8 *Sect. 6.* They shall hold annual sessions in the  
9 shire town of each county at the times following:

10 In the county of Androscoggin, on the first Tues-  
11 day of April and October. In the county of Aroos-  
12 took, on the third Tuesday of January and the first  
13 Tuesdays of June and July. In the county of Cum-  
14 berland, on the first Tuesdays of January and June.  
15 In the county of Franklin, on the last Tuesdays of  
16 April and December. In the county of Hancock,  
17 on the fourth Tuesday of January and the second  
18 Tuesdays of April and October. In the county of  
19 Kennebec, on the third Tuesdays of April and  
20 August and the last Tuesday of December. In the  
21 county of Knox, on the first Tuesdays of April and  
22 December and the third Tuesday of August. In  
23 the county of Lincoln, on the second Tuesday of  
24 May, the first Monday of September and the last  
25 Monday of December. In the county of Oxford,  
26 on the second Tuesday of May, and first Tuesday  
27 of September. In the county of Penobscot, on the  
28 first Tuesdays of April and August, and second  
29 Tuesday of December. In the county of Piscata-  
30 quis, on the first Tuesdays of April, August and  
31 December. In the county of Sagadahoc, on the  
32 first Tuesdays of March, July and November. In  
33 the county of Somerset, on the first Tuesdays of  
34 March and August, and second Tuesday of De-  
35 cember. In the county of Waldo, on the third

36 Tuesdays of April, August and December. In  
37 the county of Washington, at Machias on the first  
38 Tuesdays of January and October, and at Calais  
39 the fourth Tuesday of April. In the county of  
40 York, at Alfred on the second Tuesdays of April  
41 and October.

This act shall take effect when approved.
