STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND EIGHTY.

AN ACT to incorporate the State of Maine Consolidated Mining Company.

Whereas, the objects of this corporation cannot otherwise be obtained, therefore

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECTION 1. Frederick Robie, Nathan Cleaves,
2 George W. Kimball, jr., Fred E. Richards, Enoch
3 C. Farrington, S. S. Marble and Davis Tillson, with
4 their associates and successors, are hereby consti-
5 tuted a body politic and corporate by the name of
6 the State of Maine Consolidated Mining Company,
7 with all the rights, powers and privileges, and sub-
8 ject to all the duties and liabilities provided in the
9 public laws of this state concerning manufacturing
10 corporations, the capital stock of which is one mil-

11 lion dollars, to be divided into shares of such de-
12 nomination as the corporation may hereafter deter-
13 mine, the holders of which, their successors and
14 assigns, shall constitute a body politic and corpor-
15 ate, and by the name aforesaid, and shall have con-
16 tinued succession, may sue and be sued, complain,
17 petition and defend, may make and use a common
18 seal and alter the same at pleasure, and shall have
19 the right to enjoy the fee simple or other title to
20 such real and personal estate as may be necessary
21 to prosecute the business of the corporation; may
22 sell and dispose of the same for like purposes, may
23 make and execute by-laws, rules and regulations
24 proper for carrying into effect the provisions and
25 purposes of this act not inconsistent with law, and
26 shall have the usual and necessary powers of cor-
27 porations for the accomplishment of its objects,
28 which are hereby declared to be the quarrying, ex-
29 cavating, mining and otherwise working for ores
30 and minerals, and reducing, smelting, and other-
31 wise converting the same into base or precious bul-
32 lion, and selling the same.

SECT. 2: Said corporation, for the purpose of car-
2 rying on its business, shall have exclusive use of
3 all wharves and landings constructed by them upon
4 their own land, under the laws of the state.

SECT. 3. Any two persons named in this act may
2 call the first meeting of said corporation for pur-
3 poses of organization, by giving written notice
4 thereof to each of the other corporators three days
5 at least before said meeting.

SECT. 4. This act shall take effect when approved.
