STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND BIGHTY.

AN ACT additional for the management of the Maine Insane Hospital.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. Section one of chapter two hundred 2 and fifty-six of the public laws of eighteen hun-3 dred seventy-four is hereby amended so as to read 4 as follows:

5 Sect. 1. The government of the Maine insane 6 hospital is vested in a committee of six trustees, 7 one of whom shall be a woman, appointed by the 8 governor, with advice of the council, and commis-9 sioned to hold their offices during the pleasure of 10 the governor and council, but not more than three 11 years under any one appointment. But all ap-

12 pointments hereafter made shall be so divided into13 three classes that the term of two trustees shall14 expire each year.

SECT. 2. Section six of chapter one hundred and 2 forty-three of the revised statutes, is hereby amend-3 ed so as to read as follows:

4 Seet. 6. They shall hold an annual meeting on 5 the second Wednesday of December, at which 6 time there shall be made a full and detailed report, 7 containing a particular statement of the condition, 8 concerns and wants of the hospital, and this report, 9 and the report of the superintendent and steward, 10 shall be made up to the first day of December, and 11 laid before the governor and council at that time, 12 for the use of the government.

SECT. 3. Section eight of chapter two hundred 2 and fifty-six of the public laws of eighteen hun-3 dred and seventy-four is hereby amended so as to 4 read as follows:

5 Sect. 8. The committee of visitors shall make 6 report to the governor and council on the second 7 Wednesday of December annually, and so much 8 oftener as the welfare of the patients or the public 9 good may require, setting forth their doings and 10 any other facts with regard to the hospital which 11 they may deem important to be laid before the

12 public. The compensation of said committee shall 15 be two dollars each per day for the time actually 14 spent in visiting the hospital, and actual traveling ex-15 penses; *provided*, the said committee do not receive 16 compensation as councillors for the same days in 17 which said official visits are made to said hospital; 18 and their accounts, including a reasonable sum for 19 the letter carrier provided for in section five, shall 20 be audited by the governor and council, who shall 21 draw their warrant on the treasurer of the state for 22 the amount found due.

SECT. 4. This act shall take effect when approved.
