## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND EIGHTY.

AN ACT to incorporate the Consolidated Eastern Slate Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. John F. Sprague, Charles W. Fol-

- 2 som, and Charles S. Pullen, with their associates
- 3 and successors, are hereby made a corporation, by
- 4 the name of the consolidated eastern slate com-
- 5 pany, for the purpose of quarrying in the town of
- 6 Monson, in the county of Piscataquis, manufactur-
- 7 ing, storing and selling slate in its various forms,
- 8 with the right to construct and maintain tramways,
- 9 railroads and bridges from their works, and to
- 10 transport thereon, the waste and product from their
- 11 quarries, to and upon any lands the corporation

- 12 may own, and deposit the waste thereon, with all
- 13 the rights and privileges, and subject to all the
- 14 duties and liabilities of similar corporations under
- 15 the general laws of the state.
  - Sect. 2. Said company shall also have the right
  - 2 to build, maintain, lease and operate a line of rail-
  - 3 road, to connect their quarries with the nearest
  - 4 operating railroad constructed under the laws of
  - 5 the state, for the purpose of transporting their
  - 6 products, workmen, material and other freight.
  - 7 Said company, in building, maintaining and operat-
  - 8 ing said railroad, shall be governed by the general
  - 9 laws relating to railroads.
    - SECT. 3. The capital stock of said company
  - 2 shall not exceed one million of dollars, and be
  - 3 divided into shares of one hundred dollars each.
    - SECT. 4. Said corporation may take, hold and
  - 2 dispose of, at pleasure, real estate not exceeding at
  - 3 any one time its capital stock in value, for the pur-
  - 4 pose of its business, present or prospective.
    - SECT. 5. This act shall take effect when approved.
