STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND EIGHTY.

AN ACT amendatory of, and additional to, an act to incorporate the Rumford Falls and Buckfield Railroad Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows :

SECTION 1. The act to incorporate the Rumford Falls and Buckfield railroad company, approved the third day of March, one thousand eight hundred and seventy-four, is hereby amended, in the first section thereof, by inserting immediately after the end of such section, the following words, viz: The said Rumford Falls and Buckfield railroad company shall also have the right to lease, of private persons or corporations, the road, road-bed, bridges, track, and other property of the Portland

11 and Oxford central railroad company, on such term
12 of years as may be agreed upon by the parties;
13 and the said Portland and Oxford central railroad
14 company, or any corporation which may hereafter
15 be formed of the holders of bonds and coupons
16 issued by said last-named company, dated the twen-
17 tieth day of March, one thousand eight hundred
18 and sixty-three, shall have the right to sell and con-
19 vey, or to lease, the road, road-bed, track, bridges,
20 buildings, franchise, and other property of said cor-
21 poration, to the Rumford Falls and Buckfield rail-
22 road company, or to any other railroad corporation
23 now or hereafter to be organized, or to any person;
24 and the said Rumford Falls and Buckfield railroad
25 company shall have the right to take and hold the
26 said property, by purchase or lease, of any corpor-
27 ation or person holding the same, and it is author-
28 ized and empowered to purchase any or all of the
29 bonds and coupons aforesaid.

SECT. 2. The right, capacity, and power of the
2 Rumford Falls and Buckfield railroad company to
3 make any of the leases and purchases before men-
4 tioned, and to hold, for itself, the property and
5 rights leased or conveyed to it, shall not be limited,
6 restrained, or affected by its appointment, as re-
7 ceiver of the Portland and Oxford central railroad

8 company, or by its assumption and exercise of the
9 duties of said receivership.
