STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND EIGHTY.

AN ACT to prevent the obstruction of business on certain public corporations.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. Any employee of a railroad corpora-2 tion who, in pursuance of an agreement or combi-3 nation by two or more persons to do or procure to 4 be done, any act in contemplation or furtherance of 5 a dispute between such corporation and its em-6 ployees, shall unlawfully or in violation of his duty 7 or contract, stop or unnecessarily delay or aban-8 don, or in any way injure a locomotive or any car 9 or train of cars on the railroad track of such cor-10 poration, or in any way hinder or obstruct the use 11 of any locomotive, car or train of cars on the rail-

12 way of such corporation, shall, upon conviction, be13 liable to a fine not exceeding five hundred dollars14 or imprisonment in the state prison or in the county15 jail not exceeding one year.

SECT. 2. Whosoever, by any unlawful act, or by 2 any wilfull omission or neglect, shall obstruct or 3 cause to be obstructed any engine or carriage on 4 any railway, or shall aid or assist therein; or who-5 soever, having charge of any engine or carriage 6 while upon or in use on any railway of any railroad 7 corporation, shall wilfully stop, leave or abandon 8 the same, or render, or aid or assist in rendering 9 the same unfit or incapable of immediate use, with 10 intent thereby to hinder, delay, or in any manner 11 to obstruct or injure the management and opera-12 tion of any railroad, or the business of any corpor-13 ation operating or owning the same, or of any 14 other corporation or person, or whoever shall aid 15 or assist therein, shall upon conviction, be liable to 16 a fine not exceeding one thousand dollars, or im-17 prisonment in the state prison or in the county 18 jail not exceeding two years.

SECT. 3. Whoever having any management of, 2 or any control either alone or with others, over any 3 railroad locomotive, car or train while being used 4 for the carriage of persons or property, or at any

5 time is guilty of gross carelessness or neglect on 6 or in relation to the management or control of the 7 same; or shall maliciously stop or delay the same, 8 in violation of the rules and regulations then in 9 force for the operation and running of the same; 10 or abstract therefrom the tools or appliances per-11 taining thereto, with intent thereby maliciously to 12 delay the same, shall, upon conviction, be liable 13 to a fine not exceeding one thousand dollars, or 14 imprisonment in the state prison or in the county 15 jail not exceeding three years.

SECT. 4. Any person who alone, or in pursuance 2 or furtherance of any agreement or combination 3 with others, to do, or procure to be done, any act 4 in contemplation or furtherance of a dispute or 5 controversy between a gas, telegraph or railroad 6 corporation and its employees or workmen, shall 7 wrongfully and without legal authority use vio-8 lence towards or intimidate any person in any way 9 or by any means, with intent thereby to compel 10 such person against his will to do, or abstain from 11 doing, any act which such person has a legal right 12 to do or abstain from doing; or shall on the prem-13 ises of such corporation induce or endeavor or 14 attempt to induce such person to leave the employ 15 and service of such corporation by bribery, or in

16 any manner or by any means, with intent thereby to 17 further the objects of such combination or agree-18 ment; or shall in any way interfere with such per-19 son while in the performance of his duty; or shall 20 threaten or persistently follow such person in a 21 disorderly manner, or injure or threaten to injure 22 his property with said intents, or either of them, 23 shall, upon conviction, be liable to a fine not ex-24 ceeding three hundred dollars, or imprisonment in 25 the county jail not exceeding three months.

SECT. 5. Any person in the employ of a railroad 2 corporation, who shall, in furtherance of the inter-3 ests of either party to a dispute between another 4 railroad corporation and its employees, refuse to 5 aid in moving the cars of such other corporation, 6 or trains in whole or in part made up of the cars of 7 such other corporation, over the tracks of the cor-8 poration employing him; or refuse to aid in loading 9 or discharging such cars, in violation of his duty 10 as such employee, shall, upon conviction, be liable 11 to a fine not exceeding five hundred dollars or 12 imprisonment in the state prison or in the county 13 jail not exceeding one year.
