## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND EIGHTY.

AN ACT to incorporate the Dudley Brook Dam Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. Israel Washburn, Jr., and John P. 2 Webber, their associates and assigns, are hereby 3 incorporated by the name of the Dudley brook 4 dam company, with all the powers and privileges 5 of similar corporations.

SECT. 2. The said corporation is authorized to 2 build dams, side dams, remove rocks, and make 3 other improvements, and raise a head of water by 4 means of said dams, to facilitate the driving of logs 5 and lumber down said Dudley brook, and for this 6 purpose said corporation may take land and

7 materials necessary to build such dams, side dams, 8 and other improvements, and may flow contiguous 9 lands necessary to raise a head of water on such 10 dams and other improvements, and if the parties 11 cannot agree upon the damages the corporation shall 12 pay the proprietors of the land and material so 13 taken, such damages as shall be ascertained and 14 determined by the county commissioners for the 15 county of Aroostook, in the same manner and under 16 the same conditions and limitations as are by law 17 provided in case of damage by laying out public 18 highways, and for the damage occasioned by flow-19 ing land, the said corporation shall not be liable to 20 an action at common law, but the person injured 21 may have a remedy by a complaint for flowing, in 22 which the same proceedings shall be had as when 23 a complaint is made under a statute of this state, 24 for flowing lands occasioned by raising a head of 25 water for the working of a mill.

SECT. 3. The said corporation may demand and 2 receive a toll for the passage of logs over any of 3 their said dams and improvements, of twenty cents 4 for each thousand feet, board measure, Wood's 5 scale, and said corporation shall have a lien upon 6 all logs which may pass over any of their said 7 dams or improvements, for the payment of said

8 toll, but the logs of each particular mark shall be 9 holden only for the toll of such mark, and unless 10 such toll is paid within twenty days after such 11 logs or a major part of them shall arrive at the 12 Penobscot boom, or place of manufacture, said 13 corporation may sell at public auction so much of 14 said logs as shall be necessary to pay such toll, 15 costs and charges; notice of the time and place of 16 such sale being first given in some newspaper 17 printed in Bangor. And when the said corpora-18 tion shall, from tolls, be reimbursed, with ten per 19 centum interest, for their expenditures, the toll 20 shall cease.

SECT. 4. This act shall take effect when approved.
