STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND
EIGHTY-ONE.

AN ACT to authorize the Bridgton Telegraph Company to discontinue and remove its present line of telegraph, and to own, construct, maintain and operate a line or lines of telegraph along the line of certain railroads if built.

*Be it enacted by the Senate and House of Representatives
in Legislature assembled, as follows :*

SECTION 1. The Bridgton Telegraph Company,
2 as incorporated by chapter two hundred and fifteen
3 of the private and special laws of eighteen hundred
4 and seventy-six, is hereby authorized to discontinue
5 the use of, and to remove the wires and materials
6 of the present line of telegraph, as now owned and
7 maintained by said Bridgton Telegraph Company,

8 if deemed necessary or expedient by said Tele-
9 graph Company.

SECT. 2. The said Bridgton Telegraph Company
2 is hereby authorized to own, construct, maintain
3 and operate a line or lines of telegraph, with all the
4 rights and privileges, and subject to all the restric-
5 tions contained in said chapter two hundred and
6 fifteen, from Bridgton in the county of Cumber-
7 land, along the line or lines of any railroad or rail-
8 roads that may be built from said Bridgton to the
9 city of Portland, from said Bridgton to the line of
10 the Portland and Ogdensburg railroad, from said
11 Bridgton to the line of the Portland and Rochester
12 railroad, from said Bridgton to the line of the
13 Grand Trunk railroad or Atlantic and St. Law-
14 rence railroad, and along the entire line of any
15 railroad running through any part of said Bridg-
16 ton, from the starting point or point of connection
17 of said last named railroad with any railroad now
18 in existence, to the terminus of the same, with the
19 full right and power by agreement with other per-
20 son or persons or bodies corporate, to connect the
21 line or lines of telegraph owned and maintained by
22 said Bridgton Telegraph Company, with other lines
23 of telegraph within or without the state, or with
24 any other line of telegraph.

SECT. 3. This act shall take effect when ap-
2 proved.
