STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND
EIGHTY-ONE.

AN ACT to incorporate the Maine State Bar Association.

*Be it enacted by the Senate and House of Representatives
in Legislature assembled, as follows:*

SECTION 1. Josiah H. Drummond, Almon A.
2 Strout, Charles F. Libby, James D. Fessenden,
3 Peter C. Keegan, L. H. Hutchinson, A. R. Sav-
4 age, S. Clifford Belcher, L. A. Emery, George F.
5 Holmes, Byron D. Verrill, Orville D. Baker,
6 Lorenzo Clay, G. C. Vose, A. M. Spear, C. H.
7 Fisher, A. H. Walker, George D. Bisbee, Charles
8 F. Woodard, Thomas W. Vose, O. G. Hall, George
9 A. Emery, Joseph A. Locke, D. N. Mortland,
10 William Freeman, M. N. McKusick, Albion G.
11 Bradstreet, Lauriston R. King, and all persons

12 who may hereafter become associated with them,
13 are hereby created a corporation by the name of
14 the Maine State Bar Association, for the purpose
15 of promoting the interests of the legal profession,
16 and of instituting legal reforms, and by that name
17 shall have power to sue and be sued, and possess
18 all the rights and privileges of corporations under
19 the laws of the state.

SECT. 2. Said corporation shall elect such officers
2 as it may deem necessary, and may take, hold and
3 convey real and personal property to an amount
4 not exceeding fifty thousand dollars in value, and
5 may adopt such constitution, by-laws, rules and
6 regulations, not inconsistent with the laws of this
7 state, as they may deem proper for the manage-
8 ment of their affairs, including the admission, gov-
9 ernment and expulsion of members.

SECT. 3. The first meeting of the corporation
2 shall be called by any one of the persons named in
3 said act, by publishing seven days' notice of the
4 time and place of the same in the Kennebec Daily
5 Journal.

SECT. 4. This act shall take effect when ap-
2 proved.
