## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND-EIGHTY-ONE.

AN ACT setting off a part of the town of Caribouand annexing it to Connor plantation.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. So much of the town of Caribou as

- 2 lies west of Madawaska stream and north of a line-
- 3 commencing at the north-west corner of lot num-
- 4 bered sixty-three, in that part of Caribou formerly
- 5 I township, and running thence easterly on lot
- 6 lines directly to the north-east corner of lot twenty-
- 7 one in said I; thence northerly on the line between
- 8 lots twenty-two and one hundred and eight, to the
- 9 north-west corner of lot numbered one hundred
- 10 and eight; thence easterly on the south line of lots-
- 11 numbered one hundred and fourteen and one hun-
- 12 dred and fifteen, to said Madawaska stream, is

- 13 hereby set off from said town of Caribou and an-
- 14 nexed to and made a part of Connor plantation,
- 15 (K township, range 2).
  - Sect. 2. The town of Caribou is hereby relieved
  - 2 from all future liability on account of pauper set-
  - 3 tlements now existing, or hereafter arising by vir-
  - 4 tue of residence upon the territory hereby set off,
  - 5 of any pauper or any person under whom a settle-
  - 6 ment is derived.
    - SECT. 3. All officers of said Caribou shall have
  - 2 the same powers as to all taxes now assessed and
  - 3 unpaid, upon polls resident upon, or estates located
  - 4 within said territory set off, as they have by law as
  - 5 to other polls or estates within said Caribou.
  - SECT. 4. The inhabitants hereby set off, with
  - 2 their estates and all the taxable property in that
  - .3 part of the town hereby set off, shall be liable, and
  - 4 may be assessed in said Caribou, for a share of the
  - 5 present corporate debt of said Caribou, equal to not
  - 6 exceeding five percent. of the estates so set off, or
  - .7 any less sum which the town of Caribou by lawful
  - 8 vote may agree to, with interest thereon at five per
  - 9 cent. per annum, to be assessed and collected by
- 10 the officers of said Caribou, the same as if this act
- 11 had not been passed; provided, however, that said
- 12 six per cent., and said sum agreed to by the town

- 13 shall not exceed a fair proportion of said town in-
- 14 debtedness, and of said share of indebtedness there
- 15 shall be assessed and collected fifty dollars annu-
- 16 ally, with interest at six per cent. upon all of said
- 17 share not assessed added to said fifty dollars, until
- 18 said share shall all have been assessed.
  - Sect. 5. In case of dissatisfaction on the part
  - 2 of those hereby set off, as to the determination of
  - 3 what is a fair share of such indebtedness, it shall
  - 4 upon written request signed by a majority of the
  - 5 legal voters upon the territory hereby set off, be
  - 6 left to the arbitrament of David Dudley and Henry
  - 7 R. Downs, of Presque Isle, who after giving rea-
  - 8 sonable notice, may hear and decide, and their
  - 9 decision shall be final.
    - SECT. 6. This act shall take effect from and
  - 2 after its acceptance by a majority vote of said town
  - 3 of Caribou, and a majority vote of the legal voters
  - 4 in said Connor plantation, in the manner follow-
  - 5 ing: Within seven days after this act shall have
  - 6 been approved by the governor, the selectmen of
  - 7 the town of Caribou, and the assessors of Connor
  - 8 plantation, shall call a meeting of their respective
  - 9 town and plantation to decide on the acceptance
- 10 of this act, and the following question by suitable
- 11 article in the warrants for said meetings, shall be

12 submitted to said town and said plantation at said 13 meetings: "Shall so much of the town of Cari-14 bou as is described in act of the legislature of 15 eighteen hundred and eighty-one for setting off a 16 part of Caribou on to Connor plantation be so set

17 off?"

Sect. 7. This act shall take effect when ap2 proved.
