STATE OF MAINE.

RESOLVE laying a tax on the counties of the state for the years eighteen hundred and eighty-one and eighteen hundred and eighty-two.

Resolved, That the sums annexed to the counties
2 in the following schedule are hereby granted as a
3 tax on each county respectively, to be appropriated,
4 assessed, collected, and applied for the purpose of
5 paying the debts and necessary expenses of the
6 same, and other purposes ordered by law, for the
7 year one thousand eight hundred and eighty-one,
8 to wit:

9 Androscoggin, twenty-seven thousand dollars;
10 Aroostook, sixteen thousand dollars;
11 Cumberland, sixty-two thousand dollars;
12 Franklin, seven thousand dollars;
13 Hancock, eleven thousand five hundred dollars;

- 14 Knox, eighteen thousand dollars;
- 15 Kennebec, thirty-seven thousand dollars;
- 16 Lincoln, nine thousand two hundred dollars;
- 17 Oxford, ten thousand five hundred dollars;
- 18 Penobscot, forty thousand dollars;
- 19 Piscataquis, six thousand dollars;
- 20 Sagadahoc, fifteen thousand dollars;
- 21 Somerset, thirteen thousand dollars;
- 22 Washington, thirteen thousand dollars;
- 23 Waldo, sixteen thousand dollars;
- 24 York, twenty-two thousand five hundred dollars.
- 25 For the year one thousand eight hundred and
- 26 eighty-two, the following sums, to wit:
- 27 Androscoggin, twenty-seven thousand dollars;
- 28 Aroostook, sixteen thousand dollars;
- 29 Cumberland, forty-six thousand dollars;
- 30 Franklin, seven thousand dollars;
- 31 Hancock, eleven thousand five hundred dollars;
- 32 Knox, seventeen thousand dollars;
- 33 Kennebec, thirty-six thousand dollars;
- 34 Lincoln, eight thousand nine hundred dollars;
- 35 Oxford, ten thousand five hundred dollars;
- 36 Penobscot, thirty-five thousand dollars;
- 37 Piscataquis, six thousand dollars;
