## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND EIGHTY-ONE.

AN ACT to incorporate the Piscataquis Game and Fish Protective Society.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. John F. Sprague, Edwin R. Haynes, 2 John C. Tripp, Fred J. Wilkins, Albert W. Cha-3 pin, Albert D. Sherman, W. T. Macomber, J. D. 4 Cushman, C. S. Pullen, C. M. Coombs, Eben M. 5 Bray, Geo. F. Jackson of Monson, in the county 6 of Piscataquis, and George A. Mathews of Ando-7 ver, Massachusetts, and E. T. Rowell and H. A. 8 Hildreth of Lowell, Massachusetts, with their as-9 sociates and successors, are hereby incorporated 10 into a body politic, by the name of the Piscataquis 11 Game and Fish Protective Society.

SECT. 2. This corporation, for the purpose of

2 protecting game and fish, by aiding in the enforce-3 ment of the laws of the state relating thereto, and 4 encouraging the propagation of game and fish, is 5 hereby empowered, for such purposes, to take by 6 purchase, bequest, or otherwise, and to hold, trans-7 fer and convey real and personal property to the 8 amount of twenty thousand dollars.

SECT. 3. Said corporation shall have power to 2 prosecute and defend suits at law and in equity, 3 to enter and prosecute complaints against any per-4 son or persons for violation of any of the laws of 5 the state for the protection of game or fish, and to 6 recover and to receive all penalties and forfeitures 7 that would be recoverable by any person or any 8 game or fish warden making such complaints, to 9 have and use a common seal, and to be governed 10 by a code of by-laws not inconsistent with the 11 laws of the state.

SECT. 4. The first meeting of said corporation 2 may be called by any three of the corporators, by 3 a notice specifying the time and place of such 4 meeting, published in the Piscataquis Observer, 5 a paper published at Dover, at least one week 6 prior to the time fixed for said meeting.

SECT. 5. This act shall take effect when ap-2 proved.
