STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND EIGHTY-ONE.

AN ACT for the promotion of medical science.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- Section 1. Whoever wilfully and knowingly
- 2 shall have in his possession, for anatomical pur-
- 3 poses, the body or any part thereof, of any person
- 4 dying within this state, unless the same shall be
- 5 obtained in the manner provided by section two of
- 6 chapter thirteen of the revised statutes, or in the
- 7 manner provided by this act, shall be punished by
 - 8 imprisonment of not more than five years, or by
 - 9 fine not exceeding three thousand dollars.
 - Sect. 2. If any person, a resident of this state,
 - 2 requests or consents, during his life, that his body
 - 3 may be delivered to a regular physician or sur-

- 4 geon, for the advancement of anatomical science 5 after his death, it may be used for that purpose, 6 unless some kindred or family connection makes 7 objection.
- Sect. 3. The body of any person dying in this 2 state, which shall not be claimed, reasonable notice 3 being given for burial by the family or next of kin 4 of such person, shall be subject to the use of the 5 medical school of Maine for anatomical purposes, 6 as hereinafter provided; and if at any time said 7 school shall receive a greater number of bodies 8 than it needs for the instruction of its students, it 9 shall be authorized to deliver the excess to any 10 regular physician or surgeon for the same purpose 11 in this state.
- SECT. 4. Persons having the care of such bodies 2 shall forthwith notify the municipal officers of 3 the town in which such bodies are, and upon the 4 reception of such notice, the municipal officers of 5 such town shall immediately notify, by mail or 6 otherwise, the officers of the medical school of 7 Maine, and such notice shall state the age and sex 8 of the deceased, and the cause of death if known, 9 and on request of the officers of said school, if 10 made within two days after receiving such notice, 11 said municipal officers shall deliver such bodies

- 12 to such officers, or to any regular physician or
- 13 surgeon by them designated to receive the same.
- 14 But before receiving any such body, said medical
- 15 school, physician or surgeon shall give bond to the
- 16 treasurer of such town as provided in section two
- 17 of chapter thirteen of the revised statutes. Any
- 18 person who shall knowingly violate the provisions
- 19 of this section, shall forfeit the sum of thirty dol-
- 20 lars, to be recovered by an action of debt, one-half
- 21 to the use of the prosecutor, and one-half to the
- 22 use of said medical school of Maine.

Sect. 5. All acts and parts of acts inconsistent

2 herewith, are hereby repealed.
