## STATE OF MAINE.

RESOLVE making an appropriation for the Penobscot Tribe of Indians, for the years of eighteen hundred and eighty-five and eighteen hundred and eighty-six.

Resolved, That there be paid from the State 2 Treasury, to the agent of the Penobscot Indians, 3 to be appropriated for the benefit of said tribe, 4 each year, as follows: Forty-four hundred and 5 twenty-nine dollars and seventy cents, amount of 6 interest on their trust fund, held by the State, for 7 the benefit of said tribe; seventeen hundred dol-8 lars of their annual annuity each year; seven hunged dollars for agricultural purposes each year; 10 four hundred and fifty dollars for bounty on crops 11 each year; two hundred dollars for salary of agent 12 each year; one hundred and fifty dollars to pay a

13 competent person to instruct and assist said In-14 dians in their agricultural labors each year; six 15 hundred dollars for schools each year; to be used 16 in employing competent teachers, viz: Four hun-17 dred dollars for Oldtown Island, under the super-18 vision of the agent of said tribe, and resident 19 priest; seventy-five dollars for Olamon Island, 20 under the supervision of the superintending school 21 committee of Greenbush; one hundred and twenty-22 five dollars on Mattanawcook Island, under the 23 supervision of the superintending school com-24 mittee of Lincoln; and said committee are required 25 to report as directed in resolve approved March 26 seventeen, eighteen hundred and sixty, and it shall 27 be the duty of said agent to see that the money is 28 fully expended for the education of the children 29 of the tribe; one hundred dollars for the salary of 30 said priest, for each year, provided he says mass 31 at least twenty-four Sundays during the year, for 32 said tribe of Indians; fifty dollars for salary of 33 Governor each year; forty dollars for salary of 34 their Lieutenant Governor each year; one hun-35 dred, from the amount of shore rent for municipal 36 purposes, for said tribe each year; and one hun-37 dred dollars to be expended in building a road on

- 38 Oldtown Island, if necessary; all the foregoing
- 39 sums to be expended under the direction of the
- 40 Governor and Council.

#### STATEMENT OF FACTS.

This resolve in favor of the Penobscot Tribe of Indians, making appropriations in the usual way of previous Legislatures.
