STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND
EIGHTY-FIVE.

AN ACT to amend section seven of chapter seven
of the Revised Statutes, relating to the Northern
Registry District of Aroostook County.

*Be it enacted by the Senate and House of Representatives
in Legislature assembled, as follows:*

SECTION. 1. Section seven of chapter seven of
2 the Revised Statutes is hereby amended by striking
3 out the words "thence south to the north-east
4 corner of township numbered thirteen in the third
5 range" in the fifth and sixth lines of said section,
6 and inserting in place thereof the words, 'thence
7 north to the north-east corner of township num-
8 bered fifteen in the third range, thence west to the
9 north-west corner of said township numbered
10 fifteen in the third range, thence south to the
11 south-west corner of township numbered fifteen in
12 the third range, thence west to the north-west

13 corner of township numbered fourteen in the fourth
14 range, thence south to the south-west corner of
15 township number fourteen in the fourth range,' so
16 that said section, as amended, shall read as follows:

'All that part of the county of Aroostook lying
18 north of a line commencing at the south-east corner
19 of township F, in the first range, west from the
20 east line of the State, thence west on the south line
21 of said township and the south line of township K
22 in the second range, to township numbered fifteen
23 in the third range, thence north to the north-east
24 corner of township number fifteen in the third
25 range, thence west to the north-west corner of
26 township numbered fifteen in the third range, thence
27 south to the south-west corner of township number-
28 ed fifteen in the third range, thence west to the
29 north-west corner of township numbered fourteen
30 in the fourth range, thence south to the south-west
31 corner of township numbered fourteen in the fourth
32 range, thence west on the dividing line of town-
33 ships thirteen and fourteen to the seventh range
34 line, thence north to the north-east corner of town-
35 ship numbered thirteen in the eighth range, thence
36 west to the west line of the State, compose the
37 Northern Registry District of Aroostook county;
38 and the Register shall keep his office in the town
39 of Madawaska.
