STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND EIGHTY-FIVE.

AN ACT to establish an Agricultural Experiment Station.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. That, for the purpose of protection

- 2 from frauds in commercial fertilizers, and from
- 3 adulterations in foods, feeds and seeds, and for the
- 4 purpose of promoting agriculture by scientific in-
- 5 vestigation and experiment, the Maine Fertilizer
- 6 Control and Agricultural Experiment Station is
- 7 hereby established in connection with the State
- 8 College of Agriculture and Mechanic Arts.
 - SECT. 2. The direction and management of this
- 2 station shall be committed to a board of managers
- 3 to consist of five members, namely: The professor

- 4 of agriculture of the State College of Agriculture
- 5 and Mechanic Arts, ex-officio; the secretary of the
- 6 state board of agriculture, ex-officio; and three
- 7 members to be appointed by the governor, whose
- 8 terms of office shall be three years, except in the
- 9 first appointment one shall be designated to serve
- 10 but one year, and one to serve two years.
 - Sect. 3. The board of managers shall be called
 - 2 together by the secretary of the board of agricul-
 - 3 ture at such places in this state as he may designate,
 - 4 within thirty days of the approval of this act, for
 - 5 the purpose of transacting such business as may
 - 6 be required to put the station in operation; and
 - 7 thereafter the board of managers shall hold a
 - 8 meeting annually, at Augusta, on the Tuesday
- 9 preceding the third Wednesday of January, for
- 10 the transaction of business relating to the station.
- 11 Other meetings may be called, on due notice, by
- 12 the president, at such times and places as will best
- 13 promote the objects contemplated by this act.
 - Sect. 4. The board of managers shall organize
 - 2 by the election of a president, a secretary and a
 - 3 treasurer, who shall severally hold their offices for
 - 4 one year, and until their successors are elected.
 - 5 They shall locate the station herein provided for,
 - 6 and shall appoint a director who shall have the

- 7 general management and oversight of the analyses,
- 8 investigations and experiments necessary to carry
- 9 out the purposes named in section one of this act,
- 10 and shall employ competent assistants to aid in
- 11 prosecuting the work of the station. It shall,
- 12 whenever public interest will be promoted thereby,
- 13 publish, by bulletin or otherwise, the results of its
- 14 investigations and experiments, and shall make an
- 15 annual report of its work to the governor and
- 16 council, which shall be printed and bound with the
- 17 report of the secretary of the board of agricul-
- 18 ture.
 - Sect. 5. The sum of five thousand dollars an-
 - 2 nually is hereby appropriated to the Maine Fer-
 - 3 tilizer Control and Agricultural Experiment Sta-
 - 4 tion, and the governor and council, from time to
 - 5 time, shall draw their warrant on the state treas-
 - 6 urer for such sums of money as are necessary to
 - 7 defray the expenses herein provided for, not ex-
 - 8 ceeding in any one year the appropriation herein
 - 9 named, an account of which shall first be approved
- 10 by the president and secretary of the board of man-
- 11 agers.
 - Sect. 6. The board of managers shall receive no
 - 2 compensation for time and services rendered, but

- 3 shall be reimbursed for actual expenses incurred in
- 4 the performance of their duties.

Sect. 7. Any manufacturer, company, or person

- 2 who shall offer, sell, or expose for sale in this state,
- 3 any commercial fertilizer, the price of which ex-
- 4 ceeds ten dollars per ton, shall affix to every pack-
- 5 age, in a conspicuous place on the outside thereof,
- 6 a plainly printed certificate, stating the number of
- 7 net pounds in the package sold or offered for sale,
- 8 the name, or trade mark under which the article is
- 9 sold, the name of the manufacturer, and the place
- 10 of manufacture, and a chemical analysis stating
- 11 the percentage of nitrogen, or its equivalent in
- 12 ammonia, in available form, of potash soluble in
- 13 water, and of phosphoric acid in available form,
- 14 (soluble or reverted), as well as the total phos-
- 15 phoric acid.

Sect. 8. The manufacturer, company, or person

- 2 selling or offering for sale in this state any com-
- 3 mercial fertilizers exceeding ten dollars per ton in
- 4 price, shall on or before the first day of April
- 5 annually, or before offering the same for sale, pro-
- 6 cure a license from the board of managers author-
- 7 izing the sale of said fertilizers in the state, and
- 8 shall pay for the same the sum of fifty dollars
- 9 for a single brand and fifteen dollars for each

- 10 additional brand offered for sale; and shall furnish
- 11 the secretary of the board of managers at the
- 12 time of their appointment the names of all agents
- 13 authorized by him to sell the same in this state.
 - Sect. 9 This act shall not apply to the article
 - 2 known as "porgy chum," or to fish, or fish scrap,
 - 3 or fish waste of any kind, when sold or offered for
 - 4 sale unmixed with other fertilizing material; nor
 - 5 shall it apply to parties manufacturing fertilizers
 - 6 in quantities less than twenty-five tons per year,
- 7 or to fertilizers in possession of dealers or agents
- 8 at the time of approval of this act.
- Sect. 10. The director of the station or any
- 2 person by him deputized, is hereby empowered to
- 3 select from any parcel or package of commercial
- 4 fertilizer held or offered for sale in this state, a
- 5 quantity not exceeding two pounds, which quan-
- 6 tity shall be for analysis to compare with the cer-
- 7 tificate found on the given package held or offered
- 8 for sale; and he shall select each year at least one
- 9 sample from each brand held for sale, and shall
- 10 secure its analysis at the station.
 - Sect. 11. The secretary of the board of mana-
 - 2 gers shall register in a suitable book kept in his
 - 3 office, a list of all licenses issued and of fees re-
 - 4 ceived therefor, and a list of all brands of fertil-

- 5 izers sampled; and all license fees received by the
- 6 board of managers shall be paid into the treasury
- 7 of the state.
 - SECT. 12. Any person, or party, who shall offer
- 2 or expose for sale any commercial fertilizer without
- 3 complying with the requirements of sections seven
- 4 and eight of this act, or shall permit an analysis to
- 5 be attached to any package of such fertilizers, stat-
- 6 ing that it contains a larger percentage of any one
- 7 or more of the contituents named in section seven
- 8 of this act, than it really does contain, shall be
- 9 fined not less than one hundred dollars nor more
- 10 than three hundred dollars for the first offence, and
- 11 not less than two hundred dollars nor more than
- 12 five hundred dollars for each subsequent offence;
- 13 and the offender shall in all cases also be liable for
- 14 damages sustained by the purchasers of said fertil-
- 15 izers, provided, however, that a deficiency of one
- 16 per cent of nitrogen, potash, or phosphoric acid
- 17 claimed to be contained shall not be considered as
- 18 evidence of fraudulent intent.
 - Sect. 13. All acts and parts of acts inconsistent
- 2 with this act are hereby repealed.
- Sect. 14. This act shall take effect when approved by the governor.
