EIGHTY-FIVE.

AN ACT additional to and amendatory of "An act  
to incorporate the Cedar Brook and Swift Cam-  
bridge River Improvement Company."

---

*Be it enacted by the Senate and House of Representatives  
in Legislature assembled, as follows:*

SECTION 1. Section three of the special laws of  
2 eighteen hundred and seventy-five, entitled, an act  
3 to incorporate the Cedar Brook and Swift Cam-  
4 bridge River Improvement Company, is amended  
5 by striking out the words, "three cents per log,"  
6 in the third and fourth lines, and inserting instead  
7 the words, 'thirty cents for each and every thous-  
8 and feet thereof, board measure according to the  
9 woods scale,' so that the section as amended will  
10 read as follows:

'SECT. 3. The said corporation may demand and  
12 receive as a toll for all logs that may be driven or  
13 float down said streams into the town of Upton, in  
14 said Oxford county, the sum of thirty cents for  
15 each and every thousand feet thereof, board  
16 measure, according to the woods scale; and a lien  
17 is hereby created upon said logs to continue for  
18 three months after the same shall have passed  
19 down said streams into the town of Upton afore-  
20 said, and to be enforced by attachment.'

SECT. 2. Section four of said act is amended by  
2 striking out all the words following the word  
3 "corporation," in said section, and inserting instead  
4 the words 'and also its receipts for tolls, which  
5 shall be open for inspection at all reasonable times  
6 to any person interested in the same,' so that the  
7 section when amended shall read as follows:

'SECT. 4. An account of the costs of said im-  
9 provements shall be kept by the clerk or treasurer  
10 of said corporation, and also its receipts for tolls,  
11 which shall be open for inspection at all reasona-  
12 ble times to any person interested in the same.'

SECT. 3. The capital stock of said corporation  
2 shall be divided into fifty equal shares, and any  
3 person owning timber lands from which the timber  
4 can be hauled into said streams shall have a right,

5 at any time within thirty days after the re-organi-  
6 zation of this company by the subscribers for the  
7 shares thereof, to become a stock-holder in this  
8 company, and to take the number of shares bearing  
9 the same proportion to the whole that the quantity  
10 of such land as he owns bears to all the land from  
11 which the timber can be conveniently hauled into  
12 said streams, paying therefor his proportional part  
13 of the money already expended by this company in  
14 improving said streams.

SECT. 4. When the capital stock has been sub-  
2 scribed for, the clerk of this corporation is hereby  
3 authorized to call a meeting of the share-holders  
4 by giving them seven days' notice in writing.  
5 And said share-holders may then re-organize said  
6 company and adopt a code of by-laws.

SECT. 5. All acts and parts of acts inconsistent  
2 with this act are hereby repealed.

SECT. 6. This act shall take effect when approved.
