STATE OF MAINE.

RESOLVES to correct certain clerical errors in the
State Valuation.

Resolved, That the State valuation of eighteen
2 hundred and eighty-one relating to lands in the
3 county of Aroostook, and described under the head
4 of "Aroostook county—wild lands," upon page
5 seventeen of the printed resolves of eighteen hun-
6 dred and eighty-one, and being a part of the sched-
7 ules annexed to chapter twenty-seven of the re-
8 solves for said year, be amended as follows:

By striking out

"D. R. 2..... | 21,477 | Twenty-one thousand four hundred and |
seventy-seven dollars..... | \$21,477"

and inserting in place thereof:

"D. R. 2 | 21,791 | Twenty-one thousand seven hundred and |
ninety-one dollars..... | \$21,791"

also by striking out

"E. R. 2..... | 12,722 | Twelve thousand seven hundred and |
twenty-two dollars..... | \$12,722"

and inserting in place thereof:

'E. R. 2..... } 12,459 | Twelve thousand four hundred and fifty-
 nine dollars } \$12,459'

also by striking out

'No. 8, R. 3, W. E. L. S.. } 22,040 | Twenty-seven thousand five hundred dol-
 lars..... } \$27,500'

and inserting in place thereof:

'No. 8, R. 3, W. E. L. S.. } 21,049 | Twenty-six thousand two hundred sixty-
 three dollars..... } \$26,263'

Resolved, That the State and county taxes for the
 2 years eighteen hundred eighty-one, eighteen hun-
 3 dred eighty-two, eighteen hundred eighty-three
 4 and eighteen hundred eighty-four upon nine hun-
 5 dred and ninety-one acres of land in township
 6 number eight, range three, Aroostook county, and
 7 upon two hundred and sixty-three acres in town-
 8 ship E, range two in said county for the years
 9 eighteen hundred eighty-three and eighteen hun-
 10 dred eighty-four be and the same are hereby abated.

STATEMENT OF FACTS.

The number of acres in the townships described is as stated in the proposed amendment. The valuation per acre remains the same, the total valuation of each township being changed to conform to the actual number of acres contained in each. The resolve abates the taxes upon the number of acres in the present valuation in excess of the true number in each township, and for the years for which said taxes remain unpaid.
