STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND EIGHTY-FIVE.

AN ACT to incorporate the Maine Telephone Company of Maine.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. J. R. Bodwell, Fred Atwood,

- 2 Thomas W. Vose, Edward Swazey, their asso-
- 3 ciates, successors and assigns, are hereby created
- 4 a body corporate by the name of the Maine Tele-
- 5 phone Company, with all the rights and privileges
- 6 and subject to all the duties provided by the gen-
- 7 eral laws of this State relating to corporations,
- 8 with power by that name to sue and be sued and
- 9 to have and use a common seal and the same to
- 10 change at pleasure; to establish any and all by-
- 11 laws and regulations for the management of their

12 affairs not repugnant to the laws of this State, and 13 to do and perform any and all other legal and 14 lawful acts incident to similar corporations; and 15 said company shall have the right to locate and 16 construct its lines upon and along any public high-17 way or bridge, or along or upon the line of any 18 railroad, first having obtained consent therefor of 19 the municipal officers of any city or town in which 20 it is proposed to construct said lines and the con-21 sent of the officers of any railroad on which it is 22 proposed to build its line, between the eastern 23 and western boundaries of this State, and is here-24 by authorized and empowered to carry on the bus-25 iness of providing practical telephonic communi-26 cation by usual and proper methods and in the 27 prosecution thereof to locate, construct, maintain 28 and operate acoustic, magnetic and electric tele-29 phone lines and appurtenances, and license the 30 use of the same by others and acquire such rights 31 by lease or purchase from others throughout this 32 State, submarine, underground, upon, along and 33 over any and all public highways, bridges and 34 places, in such manner as not to endanger the 35 appropriate public use thereof, railroads canals, 36 and lands and buildings of any and all individuals, 37 societies and corporations with, first having ob-

- 38 tained consent therefor, as many lines and branches,
- 39 wires, posts and appurtenances, and terminating at
- 40 such points and places as said corporation may deem
- 41 necessary, and to remove trees and other obstacles,
- 42 except that fruit or ornamental trees shall not be
- 43 removed or defaced by trimming for said purposes,
- 44 and to connect by agreement with other telephone
- 45 lines within and without the State.
 - SECT. 2. The capital stock of said company
 - 2 shall be of such an amount as they may from time
 - 3 to time determine to be necessary for the exclusive
 - 4 purpose of constructing, maintaining and operating
 - 5 the lines of telephone hereby authorized, and they
 - 6 may purchase, hold and dispose of such personal
 - 7 and real estate as may be necessary for that
 - 8 purpose.
 - Sect. 3. This corporation is authorized to ex-
 - 2 ercise its powers, carry on its business and do all
 - 3 acts pertaining thereto in any other State or county
 - 4 upon acquiring therefor all sanction and authority
 - 5 necessary under the laws thereof.
 - SECT. 4. The damage for taking land under this
 - 2 act, when the parties cannot agree, shall be esti-
 - 3 mated, secured and paid as for land taken for
 - 4 highways.

SECT. 5. Any two of the persons named in this

- 2 act of incorporation may call the first meet-
- 3 ing of the company by giving notice thereof to
- 4 each associate.
 - SECT. 6. This company may use such telegraphic
- 2 appliances as may be necessary or convenient for
- 3 the dispatch of their business.
 - SECT. 7. Nothing in this act shall be construed
- 2 to exempt such company or its charter from the
- 3 provisions of any acts already existing or which
- 4 may hereafter be passed regulating, amending, re-
- 5 stricting or repealing the rights or privileges of
- 6 telephone companies or the charters thereof.
