STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND BIGHT HUNDRED AND EIGHTY-SEVEN.

AN ACT for the protection of Salmon and Alewives in Pleasant River, Washington County.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. From and after the passage of this

- 2 act, no person shall be allowed to take any salmon
- 3 or alewives in the waters of Pleasant River, in
- 4 Washington County, with any large nets, spears or
- 5 scoop nets, or in any weir between sunrise Friday
- 6 of each week, and sunrise Monday of each succeed-
- 7 ing week, under a penalty of twenty dollars for
- 8 each and every fish so taken.

- Sect. 2. The owner or owners of all weirs and
- 2 other machines placed in said waters, for the pur-
- 3 pose of taking said fish, shall cause the same to be
- 4 kept open from sunrise on Friday of each week,
- 5 till sunrise Monday of each succeeding week, under
- 6 a penalty of fifty dollars for each offence.
- Sect. 3. No person shall build or place in said
- 2 waters, for taking alewives, any weir of any kind
- 3 whatever, higher than a half tide weir, under a
- 4 penalty of fifty dollars.
- Sect. 4. It shall be the duty of each town and
- 2 plantation, Beddington excepted, through which
- 3 said river passes, at their annual meeting in March
- 4 or April, to choose three suitable persons for a fish
- 5 committee, who shall be sworn faithfully and im-
- 6 partially to discharge the duties required of them
- 7 by this act.
 - Sect. 5. There shall be good and sufficient fish-
- 2 way for the passage of salmon and alewives, made
- 3 over or around every dam, in or across said river or
- 4 any of its branches where said fish have usually
- 5 passed, by the owners or occupants of said dams;
- 6 and said fish-ways shall be kept open at all times
- 7 between the fifteenth day of May and the fifteenth
- 8 day of September in each year; and any owner or
- 9 occupant of such dam who shall neglect or refuse

- 10 to make and keep open such fish-way after ten
- 11 days' notice in writing by said committee, shall
- 12 forfeit a sum not less than one hundred dollars for
- 13 every offence.
 - Sect. 6. No person shall erect any eel weir in
 - 2 any part of said river or its branches, or in any of
 - 3 its lakes, from or through which said river may
 - 4 flow, so as to stop or impede the passage of said
 - 5 fish in said river, or take said fish in eel pots, under
 - 6 a penalty of ten dollars.
 - SECT. 7. All nets, seines, craft, barrels and salt
 - 2 used in taking or curing fish in violation of this
 - 3 act, and all fish so taken shall be forfeited and may
 - 4 be seized by said committee or any one of them,
 - 5 when so used, and shall be proceeded against as
 - 6 directed in the act prescribing the mode of recov-
 - 7 ering forfeitures of personal property liable thereto
 - 8 by law.
 - Sect. 8. No person shall take fish of either of
 - 2 the kinds aforesaid, within a line three rods below
 - 3 the lower roll dam, and a line one rod above the
 - 4 Harris dam on said river, unless permitted to do so
 - 5 by the fish committee, for the propagation of said
 - 6 fish, under a penalty of not less than two or more
 - 7 than twenty dollars.

- SECT. 9. If any person shall resist such fish 2 committee, or either of them, in the execution of 3 their duties prescribed by this act, he shall forfeit 4 a sum not less than ten dollars or more than fifty 5 dollars.
- SECT. 10. The inhabitants of every town and 2 plantation through which said river passes, are 3 empowered at any legal meeting, by their vote, to 4 prohibit all persons other than inhabitants and resi-5 dents of the same, from taking any of the fish 6 aforesaid, within limits of such town or plantation, 7 and any person who shall take said fish contrary to 8 such vote shall forfeit ten dollars for each and 9 every offence.
- SECT. 11. No person shall take at any time by 2 means of seine, scoop-net, or drag-net or weir, any 3 salmon, under penalty of not less than twenty or 4 more than fifty dollars for every fish so taken.
- SECT. 12. If any person having taken any ale-2 wives from said waters or purchased any so taken, 3 shall permit them to become tainted and offensive 4 to the inhabitants, he shall forfeit and pay the sum 5 of twenty dollars for each offence.
- SECT. 13. The penalties imposed by this act may 2 be recovered by action of debt, one-half to the use

- 3 of the county wherein the offence was committed,
- 4 and the other half to the use of the person who
- 5 shall sue therefor.

SECT. 14. All acts and parts of acts inconsist-2 ent with this act are hereby repealed.
