IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND  
EIGHTY-NINE.

---

AN ACT to incorporate the Randolph Mutual Fire  
Insurance Company of Randolph.

---

*Be it enacted by the Senate and House of Representatives  
in Legislature assembled, as follows:*

SECTION 1. I. F. Stevens, A. C. Clark, D. S.  
2 Tasker, G. P. H. Jewett, Daniel Glidden, William  
3 Grant, A. E. Lewis, David N. Moore, Henry P.  
4 Closson and Benj. Clark, and all others who may  
5 hereafter become members of said company, are  
6 hereby incorporated and made a body politic by the  
7 name of the Randolph Mutual Fire Insurance  
8 Company, for the purpose of insuring in the town  
9 of Randolph only, their respective dwelling houses,  
10 stores, sheds, barns and other buildings, household

11 furniture and merchandise against loss or damage  
12 by fire, whether the same happens by accident,  
13 lightning, or by any other means excepting that of  
14 design of the insured; and may purchase and hold  
15 such real estate and personal property as may be  
16 necessary to effect the object of their association,  
17 and may sell and convey the same at pleasure.

SECT. 2. Said company may make such by-laws  
2 not contrary to the laws of the State as may seem  
3 necessary or convenient for the regulation and man-  
4 agement of its affairs, and do and execute all such  
5 acts as may be necessary to carry into effect the  
6 purposes of this act.

SECT. 3. The first meeting may be called by any  
2 three persons named in this act by posting up in  
3 three public and conspicuous places in said Randolph,  
4 notice of time and place at least ten days before  
5 such meeting. At which time and place the members  
6 present may elect all needful officers, fix their com-  
7 pensation and manage their own affairs in any way  
8 not repugnant to the laws of the State relating to  
9 such companies.

SECT. 4. This act shall take effect when ap-  
2 proved.
