STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND
EIGHTY-NINE.

AN ACT further extending the charter of the Bangor Boom Company

*Be it enacted by the Senate and House of Representatives
in Legislature assembled, as follows:*

SECTION 1. The charter of the Bangor Boom
2 Company with all the rights and privileges and all
3 the responsibilities attaching to said company by
4 virtue of the several acts creating, extending and
5 relating thereto shall continue and remain in force
6 for eight years from March, 1890, *provided, how-*
7 *ever,* that said company shall receive as toll ten
8 cents for each thousand feet, in lieu of twenty
9 cents as provided in chapter seventy-five of the
10 Special Laws of the year 1881 in the case therein

11 provided of the work of driving and rafting being
12 done by one contractor, as now done.

SECT. 2. Upon application in writing by any
2 person interested in logs on the Penobscot river to
3 the surveyor general, if he is satisfied that the
4 company is not performing the requirements of
5 section two of chapter forty-nine of the Special
6 Laws of 1869, as to stray logs so called, he shall
7 appoint one or more persons to look over the booms
8 and rafting grounds of the company and if stray
9 logs, so called, are found therein, they shall be re-
10 turned to the owner, or sold after due notice; such
11 person or persons so appointed shall receive such
12 reasonable compensation as shall be agreed upon
13 with the surveyor general to be paid by the com-
14 pany, the company shall be entitled to a toll of one
15 dollar for each thousand feet of stray logs, so
16 found and returned or sold, a return of all such
17 stray logs so found shall be made to the office of
18 the surveyor general, and the proceeds of sales as
19 above shall be deposited with the surveyor general
20 to be paid to the owner if not claimed by the
21 owner within two years from the date of the sale,
22 the proceeds of such sums shall be applied to the
23 improvement of the navigation of the river as
24 provided in said section two of said chapter forty-

25 nine with reference to proceeds of logs sold as
26 therein provided. The surveyor general shall have
27 a reasonable compensation for his services to be
28 paid from such proceeds.

SECT. 3. The company may erect within its
2 limits on the easterly side of Penobscot river two
3 piers within five hundred feet southerly of Eaton
4 point and not exceeding two hundred feet from
5 the easterly bank of the river in such places; to
6 be of such size and proportions and constructed as
7 shall be determined by Joab W. Palmer and
8 William Connors of Bangor.

SECT. 4. The limits of the company are extended
2 from its present limits up river to the south bank of
3 Eaton's cove on the east side and to Thompson's
4 point on the west side.

SECT. 5. This act shall take effect when ap-
2 proved.
