STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND EIGHTY-NINE.

AN ACT to incorporate the Maine Free Baptist Association.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

Section 1. Oren B. Cheney, Rufus Deering, John M.

- 2 Lowden, Hiram J. Preble, Ebenezer D. Wade, John B.
- 3 Jordan, Simeon C. Whitcomb, Orrin W. Waldron,
- 4 Thomas H. Stacy, their associates and successors, are
- 5 hereby constituted a corporation for religious, missionary
- 6 and educational purposes, under the name of the Maine
- 7 Free Baptist Association, and by that name shall have
- 8 power to prosecute and defend suits at law, to use a
- 9 common seal, to take and hold for the objects of their
- 10 association, by gift, grant, bequest, purchase, or
- 11 otherwise, any estate, real or personal, or both, the
- 12 annual income of which shall not exceed fifty thousand
- 13 dollars, and to sell and convey any estate, real or
- 14 personal, or both, which the interests of said association
- 15 may require to be sold and conveyed.

- SECT. 2. The said association may adopt such a con-2 stitution as they may deem expedient for the management 4 of their affairs from time to time, and they shall be, and 5 they are hereby invested with all the powers, privileges, 6 rights and immunities incident to similar corporations.
- SECT. 3. The Free Baptist Maine Home Missionary 2 Society, incorporated by an act approved February 6, 3 1872, is hereby authorized to transfer and deliver to the 4 said Maine Free Baptist Association all its real and 5 personal property and estate, and existing rights, to be 6 held and used by said association for the purposes men-7 tioned in this act, and upon such transfer and delivery, 8 the act entitled an act to incorporate the Free Baptist 9 Maine Home Missionary Society, approved February 6, 10 1872, shall thereafter be null and void, and all the powers 11 and immunities of the said society shall be vested in the 12 said association.
 - SECT. 4. The first meeting of this corporation may be 2 called by Oren B. Cheney, or by any two of the persons 3 named in section one of this act, by a notice of the time 4 and place being sent to each corporator, at least seven 5 days before said meeting.

Sect. 5. This act shall take effect when approved.

Amendment to House Document.

"A." House Document No. 26, to incorporate the Maine Free Baptist Association, amended by striking out in section one, fourth line, the words "and educational," and inserting the word 'and' in the same line between "religious" and "missionary."
