## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND EIGHTY-NINE.

AN ACT to incorporate the Mexico and Rangeley
Railroad Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. Edward Plummer, Galen C. Moses,

- 2 Arthur Sewall, W. E. Plummer, and W. H. Newell,
- 3 their associates, successors, and assigns, are hereby
- 4 constituted a corporation, by the name of the
- 5 Mexico and Rangeley Railroad Company, and by
- 6 that name may sue and be sued, plead and be im-
- 7 pleaded, and enjoy all proper remedies at law and in
- 8 equity to secure and protect them in the exercise
- 9 and use of their rights and privileges, and in per-
- 10 formance of their duties under this charter; and

- 11 said corporation is hereby authorized to locate,
  12 construct and maintain, alter and keep in repair, a
  13 railroad, with one set of iron rails or tracks, for
  14 the carriage of passengers and freight for hire from
  15 a point in the town of Mexico, county of Oxford,
  16 and State of Maine, near Swift river at Mexico
  17 Corner, so-called, thence north-westerly by the
  18 most feasible route through the towns of Roxbury,
  19 Byron, Letter D and Rangeley Plantation, to a
  20 point at or near the southerly end of Mooselucma21 guntic or Great Lake, with all the powers, privileges
  22 and immunities, and subject to all the liabilities,
  23 conferred and imposed upon railroad corporations
  24 under the laws of this State.
- SECT. 2. The capital stock of said company shall 2 consist of not less than five hundred, nor more than 3 two thousand shares, of the par value of one hundred dollars each.
- SECT. 3. The officers of said corporation shall 2 consist of a board of five directors, a president, vice 3 president, treasurer and clerk, and such other officers 4 as may be provided for by the by-laws.
- SECT. 4. Said corporation shall have the power 2 to make, ordain, and establish, any by-laws, not 3 repugnant to the laws of this State.

- SECT. 5. Said corporation is authorized to issue 2 its bonds to an amount not exceeding two hundred 3 thousand dollars, and to secure the same by a mort-
- 4 gage of its road, franchise, and property, or in any
- 5 other manner.
- SECT. 6. Said corporation is hereby empowered 2 to connect at either of its termini with any railroad
- 3 or steamboat line, now in operation, or to be here-
- 4 after located, established, and placed in operation.
- SECT. 7. For the purpose of organization, any
- 2 one of the incorporators may give notice thereof
- 3 to each of their associates by letter, stating the
- 4 place and purpose, mailed to the address of each
- 5 associate, at least seven days before the date of said
- 6 meeting.

Sect. 8. This act shall take effect when approved.
