STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND
EIGHTY-NINE.

AN ACT to incorporate the South Kennebec Agricultural Society.

*Be it enacted by the Senate and House of Representatives
in Legislature assembled, as follows:*

SECTION 1. George Brown, A. N. Douglas, F.
2 H. Moore, A. B. Noyes, C. F. Achorn, H. E.
3 Howe, W. M. Achorn, E. W. Gove, R. W. Howe,
4 Eugene M. Glidden, Charles B. Jewell, C. D.
5 Northey, Jos. S. Gray, together with their asso-
6 ciates and successors, such members, associates
7 and successors being residents of and representing
8 the towns of Pittston, Randolph, Chelsea, Windsor,
9 Whitefield and Somerville, be and hereby are con-
10 stituted a body corporate and politic by the name

11 of the South Kennebec Agricultural Society, with
12 powers to prosecute and defend suits at law, to
13 have and use a common seal, to make and enforce
14 any by-laws and regulations, for the management
15 of their affairs, not repugnant to the laws of the
16 State, and shall exercise all the powers and privi-
17 leges granted to and exercised by agricultural
18 societies and similar corporations.

SECT. 2. The first meeting may be called by any
2 three of the within named corporators by publishing
3 notice of the time, place and object thereof in all of
4 the above named towns at least fourteen days before
5 the time of holding the meeting, and at said meeting
6 the officers of said corporation may be chosen and
7 such other corporate business done as may be deemed
8 proper.

SECT. 3. This act shall take effect when ap-
2 proved.

House Amendment, "A," to "Bill to incorporate the South
Kennebec Agricultural Society."

The Amendment is to strike out the words in the 8th line,
—"the towns of Pittston, Randolph, Chelsea, Windsor,
Whitefield and Somerville," and inserting therefor the words,
'the southern part of Kennebec county and the towns of
Whitefield, Jefferson and Somerville in Lincoln county.'
