STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND EIGHTY-NINE.

AN ACT to incorporate the Monticello Boom Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. Henry C. Sharp, Richard B. Ketchum,

- 2 Joel Wellington, Albert Sawyer and Albert A. Bur-
- 3 leigh, Albert W. Madigan, Llewellyn Powers and
- 4 Fred Moore, their associates, successors and assigns
- 5 are hereby created a corporation by the name of the
- 6 Monticello Boom Company with all the rights and
- 7 privileges and subject to all the duties and obliga-
- 8 tions of such corporations under the laws of the
- 9 State.

Sect. 2. Said corporation is empowered to locate, 2 build and maintain on the Monticello stream in the 3 town of Monticello in Aroostook county between 4 the northern and southern shores of said stream 5 on lot numbered forty-two (42) in said Monticello 6 piers and booms for the purpose of holding and 7 sorting logs and lumber driven down said stream 8 and intended for use and manufacture in Aroostook 9 county and of assorting and separating such logs 10 and lumber from logs and lumber intended to be 11 driven out of the State of Maine. All of said logs 12 and lumber to be held, sorted and separated only 13 upon the conditions hereinafter provided.

Provided, however, that a safe, suitable and con15 venient passage way shall be constructed through
16 and by said piers and booms for the passage of
17 logs and lumber after the same shall have been
18 sorted and separated according to the provisions of
19 this act, and the boom master hereinafter named
20 shall have sufficient crew to be kept constantly
21 employed so as not to unnecessarily detain the
22 drives passing by and hang them on Jackson's
23 Falls.

SECT. 3. Said corporation shall annually appoint 2 a boom master who shall have the management 3 and control of the sorting and separating of said

- 4 logs and lumber and who shall, during the time 5 when such logs and lumber are being driven 6 through and by said boom and piers, have charge 7 and control of all logs and lumber so being driven 8 through and by said boom and piers and of all 9 crews and men employed in driving said logs and 10 lumber and said boom master shall have only the 11 right to hold any or all of said logs and lumber a 12 sufficient time to enable him with sufficient crew 13 constantly employed, to sort and separate all logs 14 and lumber intended to be held and manufactured 15 in Aroostook county from logs and lumber intended 16 to be driven out of the State of Maine.
- SECT. 4. The booms and piers herein provided 2 for are to be built and maintained at the expense of 3 the mill owners at Monticello and the boom master 4 is to be paid by them.
- SECT. 5. Said boom master shall demand of all 2 persons having logs and lumber in any of said drives, 3 men to be employed in sorting said logs and lumber 4 in proportion to the quantity of logs said persons 5 may have in said drives, and in case said men are 6 not furnished within twenty-four hours after notice 7 to said persons or their foreman in charge on said 8 stream said boom master shall, at the expense of 9 said persons hire said sufficient number of men.
