### HOUSE AMENDMENT "A."

That section 10 be amended so that the same shall read as follows :

'SECT. 10. This act shall take effect after its approval  
2 when two-thirds of the legal voters within that portion of  
3 said corporation lying in the town of Poland and two-  
4 thirds of the legal voters in that portion of said corpora-  
5 tion lying in the town of Minot, shall concurrently vote  
6 to accept the same at separate meetings called for this  
7 purpose to be held in the said respective portions of said  
8 corporation and called and notified in said respective por-  
9 tions of said corporation in the manner provided in sec-  
10 tion fifteen of this charter ; and thereupon school district  
11 numbered one in the town of Minot shall be and stand  
12 abolished, but its corporate powers and liabilities shall  
13 continue so far as may be necessary for the enforcement  
14 of its rights and duties. The corporation created by this  
15 act shall not be abolished by any doings of the town of  
16 Minot for any purpose.

## HOUSE AMENDMENT “B.”

That section 12 be amended so that the same shall read as follows :

‘SECT. 12. The assessors of each town from which a part  
2 of said village corporation is taken, shall annually appor-  
3 tion to said corporation a share of all the school moneys  
4 derived from any source for the support of public schools  
5 in their town, according to the number of scholars in said  
6 corporation residing in said town, *provided, however*, that  
7 each of said towns and the officers thereof shall retain all  
8 the powers and privileges conferred upon towns and town  
9 officers in general by section twelve and section sixteen  
10 of chapter eleven of the Revised Statutes, and may exer-  
11 cise the same as under the school district system. Scholars  
12 not residing within the limits of said corporation may at-  
13 tend its schools if the superintending school committee or  
14 supervisor consent thereto, and on such conditions as said  
15 consenting officers may impose.
