## STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND  
EIGHTY-NINE.

---

AN ACT to regulate the compensation of Sheriffs  
and amendatory of chapter 80, Revised Statutes.

---

*Be it enacted by the Senate and House of Representatives  
in Legislature assembled, as follows:*

SECTION 1. The sheriffs of the several counties  
2 of the State shall be allowed an annual compensa-  
3 tion to be paid to them from the county treasury in  
4 quarterly payments, on the last days of March, June,  
5 September and December, as follows: The sheriffs  
6 of the counties of Androscoggin, Cumberland, Ken-  
7 nebec, Penobscot and York, the sum of six hundred  
8 dollars each; Aroostook, Franklin, Hancock, Knox,  
9 Lincoln, Oxford, Piscataquis, Sagadahoc, Somerset,  
10 Waldo and Washington, the sum of four hundred  
11 dollars each.

SECT. 2. Sections twenty, twenty-one, twenty-  
2 two and twenty-three of chapter eighty of the Re-  
3 vised Statutes are hereby repealed.

SECT. 3. Paragraph twenty-three of section five  
2 of chapter one hundred and sixteen of the Revised  
3 Statutes is hereby amended by striking out the  
4 words "two" in the second line and inserting in place  
5 thereof the word 'three,' so that said paragraph  
6 shall read as follows:

For each day's attendance by the sheriff on the  
8 supreme judicial, or either of the superior courts  
9 three dollars, to be paid from the county treasury.

SENATE AMENDMENT "A."

Strike out section one and insert the following substitute:

'Section 1. The sheriffs of the several counties of the State shall be allowed an annual compensation of three hundred dollars to be paid to them from the county treasury in quarterly payments on the last days of March, June, September and December of each year.'

Amendment "B." Add section four.

'Sect. 4. This act shall take effect when approved.'

Adopted.
