STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND EIGHTY-NINE.

AN ACT to incorporate the Crystal Ice Company.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

SECTION 1. John W. Lane, Cullen C. Chapman, 2 John F. Procter, Henry W. Sargent, with their asso-3 ciates, successors and assigns, are hereby created a 4 body corporate by the name of the Crystal Ice 5 Company, for the purpose of cutting, storing, buy-6 ing, selling, exporting and shipping ice from 7 Walker pond, so-called, in the towns of Sedgwick 8 and Brooksville in Hancock county, in the State of 9 Maine, and to have exclusively all the rights and 10 privileges of said pond and incident to corporations 11 of a similar nature.

SECT. 2. Said corporation may hold real and 2 personal property to an amount not exceeding one 3 hundred thousand dollars. The capital stock of 4 said corporation shall not exceed one hundred thou-5 sand dollars which shall be divided into shares of 6 twenty-five dollars each.

SECT. 3. Said company may issue its bonds or 2 other obligations secured by a mortgage of its fran-3 chise and other property to carry out the purposes 4 of its incorporation upon such rates and time as it 5 may deem expedient, and not to exceed its capital 6 stock.

SECT. 4. Said corporation may take and hold by 2 purchase or may take as for public use any real 3 estate easement, or right of way in said towns of 4 Brooksville and Sedgwick, necessary for the pur-5 poses of its incorporation; and any person or 6 persons sustaining damage thereby may have the 7 same determined in the manner provided by law 8 for the assessments of damages for land taken for 9 railroads, within three years from the time of such 10 taking, but if no proceedings are commenced by 11 any party so injured within said three years they 12 shall waive their right thereby to any damages for 13 such injury. SECT. 5. Any person who shall wilfully corrupt 2 or in any way render the water impure in said 3 Walker's pond or who shall throw into or leave 4 any offensive and unwholesome matter in said 5 pond, or upon the ice of said pond, when frozen 6 over, or who shall wilfully injure any of the prop-7 erty of said corporation shall pay three times the 8 amount of damages occasioned thereby, to be re-9 covered by an action on the case; and every person 10 convicted of any such offence shall be punished 11 by a fine not exceeding five hundred dollars or by 12 imprisonment not exceeding one year.

SECT. 6. Said corporation is hereby authorized 2 and empowered to build piers, and extend wharves 3 into tide waters if necessary for the prosecution of 4 its business.

SECT. 7. The first meeting for the purpose of 2 organization of said corporation shall be called by 3 any one of said incorporators by written notice stat-4 ing time and place, given to the other said incor-5 porators in hand or left at their last usual place of 6 abode at least seven days before the date of said 7 meeting.

SECT. 8. This act shall take effect when ap-2 proved.
