STATE OF MAINE.

IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED AND EIGHTY-NINE.

AN ACT to amend Chapter 147 of the Public Laws of 1887, relating to Special Insurance Brokers.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- Section 1. Section one of chapter one hundred
- 2 forty-seven of the Public Laws of eighteen hun-
- 3 dred and eighty-seven is hereby amended so as to
- 4 read as follows:
 - 'SECT. 1. The insurance commissioner of this
- 6 State, upon the annual payment of a fee of ten
- 7 dollars, may issue to citizens of this State, already
- 8 agents of one or more duly authorized fire insur-
- 9 ance companies, licenses as special insurance
- 10 brokers, permitting the person named therein to

11 procure policies of fire insurance on property in 12 this State, in foreign insurance companies that are 13 reported by the insurance officials of their States 14 or countries to be solvent, and have a capital of at 15 least one hundred thousand dollars, but are not 16 authorized to transact business in this State, also 17 mutual fire insurance companies of other States 18 that have net cash assets of one hundred thousand 19 dollars, subject to the following limitations and 20 restrictions. Said brokers shall place no risks with 21 unlicensed companies that can be placed with 22 licensed companies in this State, and shall only 23 procure insurance under such license, after he has 24 procured insurance in companies admitted to do 25 business in this State, to the full amounts which the 26 agents of said companies in the State are willing 27 to write on said property.'

SECT. 2. Section two of said act is amended so 2 as to read as follows:

'SECT. 2. Each person so licensed shall keep a 4 separate account of the business done under said 5 license, and on the last day of March, June, Sep-6 tember and December of each year, shall file with 7 the insurance commissioner, a certified copy of the 8 account of such business for the quarter then end-9 ing, showing the exact amount of such business

10 placed for any person, firm or corporation, the gross 11 premium charged therein, the companies in which 12 the same is placed, the date of the policies and the 13 term thereof; and before receiving such license, 14 shall execute and deliver to the treasurer of State 15 a bond in the penal sum of five hundred dollars 16 with such sureties as the treasurer shall approve, 17 with a condition that the license will faithfully 18 comply with all the requirements of this chapter, 19 and will file with the treasurer of State, in Janu-20 ary of each year, a sworn statement of the gross 21 premiums charged for insurance, procured or placed 22 under such license, during the year ending on the 23 thirty-first day of December next preceding, and 24 at the time of filing such statement, will pay into 25 the treasury of the State, a sum equal to one per 26 cent of such gross premiums.

Sect. 3. This act shall take effect when approved.
