STATE OF MAINE.

EN THE YEAR OF OUR LORD ONE THOUSAND BIGHT HUNDRED AND RIGHTY-NINE.

AN ACT to amend sections forty-five, fifty-two, seventy-one and seventy-four of chapter forty of the Revised Statutes, relating to migratory fish.

Be it enacted by the Senate and House of Representatives in Legislature assembled, as follows:

- Section 1. Section forty-five of chapter forty is hereby 2 repealed.
 - SECT. 2. Section fifty-two of said chapter is hereby
 - 2 amended by striking out the word "fifty" in the second
 - 3 line thereof, and inserting instead thereof the word
 - 4 "twenty-five;" and by inserting after the word "salmon,"
 - 5 in the fourth line thereof, the words "and one dollar for
- 6 each and every other fish," so that said section as amended 7 shall read as follows:
- SECT. 52. Whoever fishes for, takes, catches, kills or
- 9 destroys any fish, except in tide waters, with net, seine,
- 10 weir or trap, forfeits twenty-five dollars for the offence

- 11 and ten dollars for each salmon or land-locked salmon,
- 12 and one dollar for each and every other fish so taken,
- 13 caught, killed or destroyed.'
- Sect. 3. Section seventy-one of said chapter is hereby
- 2 amended by adding thereto the following words: 'To the
- 3 officer seizing the same,' so that said section as amended
- 4 shall read as follows:
- SECT. 71. All boats, implements and materials used, 6 and all fish taken in violation of this chapter, are forfeited 7 to the officer seizing the same.
 - Sect. 4. Section seventy-four of said chapter is hereby
 - 2 amended by striking out all of said section after the
 - 3 figures 74, and inserting instead thereof the following
 - 4 words:
 - 'All fines and penalties recovered for violations of sec-
 - 6 tions thirty, forty-one to forty-six inclusive, forty-eight
 - 7 to fifty-eight inclusive, sixty-one, sixty-three to sixty-five
 - 8 inclusive, sixty-eight and seventy, shall be paid one-half
 - 9 to the prosecutor, and the other half, and costs, to the
- 10 county where the action is brought, or the complaint or
- 11 indictment is issued.' So that said section as amended
- 12 shall read as follows:
- 'Sect. 74. All fines and penalties recovered for viola-
- 14 tions of sections thirty, forty-one to forty-six inclusive,
- 15 forty-eight to fifty-eight inclusive, sixty-one, sixty-three
- 16 to sixty-five inclusive, sixty-eight and seventy, shall be
- 17 paid one-half to the prosecutor, and the other half, and
- 18 costs, to the county where the action is brought, or the
- 19 complaint or indictment is issued.'
- SECT. 5. All acts or parts acts inconsistent with this act 2 are hereby repealed.
