IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED  
AND NINETY-ONE.

---

AN ACT concerning the Portland and Rumford Falls  
Railway, and the Rumford Falls and Buckfield  
Railroad Company.

---

*Be it enacted by the Senate and House of Representatives  
in Legislature assembled, as follows :*

SECTION 1. The Portland and Rumford Falls  
2 Railway is hereby authorized from time to time, the  
3 consent of the Rumford Falls and Buckfield Rail-  
4 road Company being first obtained, to locate, con-  
5 struct and maintain its railroad over the whole, or  
6 any part or parts of the line over which the Rumford  
7 Falls and Buckfield Railroad Company is now  
8 authorized by law to construct a railroad; but the  
9 authority herein granted shall cease as to all parts

10 of the line not constructed within five years from  
11 the approval hereof.

SECT. 2. The time within which the Rumford  
2 Falls and Buckfield Railroad Company may con-  
3 struct any line now authorized is extended to five  
4 years from the approval of this act.

SECT. 3. The lease by the Portland and Rumford  
2 Falls Railway of the railroad, franchises and property  
3 of the Rumford Falls and Buckfield Railroad Com-  
4 pany is approved, and the Portland and Rumford  
5 Falls Railway is authorized to purchase any of the  
6 stock, bonds, receiver's certificates, or other secur-  
7 ities issued by the Rumford Falls and Buckfield  
8 Railroad Company.

SECT. 4. The Rumford Falls and Buckfield Rail-  
2 road Company, and the Portland and Rumford  
3 Falls Railway, and each of them, is authorized to  
4 sell or lease the whole or any part of its railroad,  
5 property or franchises, including those acquired  
6 by lease; and any other railroad corporation may  
7 acquire any of the same by lease or purchase, or  
8 may acquire any stock, bonds, receiver's certifi-  
9 cates, or other securities issued by either the  
10 Rumford Falls and Buckfield Railroad Company  
11 or the Portland and Rumford Falls Railway.

SECT. 5. This act shall take effect on approval.
