IN THE YEAR OF OUR LORD ONE THOUSAND EIGHT HUNDRED  
AND NINETY-ONE.

AN ACT extending the powers of Mt. Desert  
Railway.

---

*Be it enacted by the Senate and House of Representatives  
in Legislature assembled, as follows :*

SECTION 1. The organization of Mt. Desert  
2 Railway, a corporation organized under the general  
3 railway laws of the State of Maine, the certificate of  
4 organization of which is dated the 17th day of  
5 November, 1883, and the renewal of its charter by  
6 the Board of Railroad Commissioners, are hereby  
7 ratified and confirmed.

SECT. 2. Said Mt. Desert Railway is hereby  
2 authorized to change its guage to four (4) feet

3 eight and one-half (8 1-2) inches, and to construct  
4 and maintain its line and operate the same by elec-  
5 tricity from some point on the seashore in Eden in the  
6 village of Bar Harbor, to the villages of Seal Harbor  
7 and Northeast Harbor, in the town of Mt. Desert,  
8 and may erect poles and wires for such method of  
9 operation.

SECT. 3. Said Mt. Desert Railway may purchase  
2 the stock, bonds, property and franchises of Green  
3 Mountain Railway, or may lease and operate said  
4 Green Mountain Railway, and said Green Mountain  
5 Railway is hereby authorized to sell or lease its  
6 franchises and property to said Mt. Desert Railway.

SECT. 4. Said Mt. Desert Railway is authorized  
2 to issue its stock and its bonds secured by a mort-  
3 gage of its property and franchises for the construc-  
4 tion and equipment of its road and for the purchasing  
5 or leasing of said Green Mountain Railway in such  
6 sum as the stockholders of said Mt. Desert Railway  
7 may by vote declare to be necessary.

SECT. 5. This act shall take effect when approved.
